**REDEFINITION OF THE LOCAL LIMITS OF DISTRICTS  
AND CREATION OF NEW DISTRICTS IN NAMIBIA AMENDMENT:  
MAGISTRATES' COURTS ACT, 1944**

Under section 2 of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944), I hereby amend the Redefinition of the Local Limits of Districts and Creation of New Districts in Namibia as published under Government Notice No. 23 of 17 February 1994 and amended by Government Notice No. 122 of 23 June 1997 as set out in the Schedule below -

**SCHEDULE**

- (1) Subparagraph (iv) of paragraph (g) is deleted.
- (2) The Schedule is amended as follows in respect of the following districts as specified in column 3 thereof:
  - (a) District of Khorixas- by the deletion of the name “Sesfontein” in column 4;
  - (b) District of Opuwo-
    - (i) by the deletion of the name “Ruacana” in column 4; and
    - (ii) by the insertion of the name “Sesfontein” after the name “Okangwati” in column 4;
  - (c) District of Uutapi- by the insertion of the name “Ruacana” after the name “Okahao” in column 4;
  - (d) District of Rundu-

- (i) by the insertion of the name "Mukwe" after the name "Kahenge" in column 4;
  - (ii) by the insertion of the name "Mukwe" in column 5 and, opposite thereto, in column 6, the expression "AA"; and
- (e) The district of Mukwe is deleted as well as the expressions "Kavango" in column 1, "AA" in column 2 and "Mukwe (seat)" and "Omega" in column 4, where they appear opposite to that district name;
- (f) District of Katima Mulilo- by the insertion in column 4 of "(seat)" after the name "Katima Mulilo" and the addition of the name "Omega".

Name of place specified as the seat of magistracy for the district: Outjo. The local limits of the Magisterial District of Outjo shall be defined as follows:

mentioned property; thence generally north-westwards along the boundaries of the following properties so as to exclude them from this area: the farms Löwenfontein 84, Renosterkop 389, Farm 388, Braunfels 387, Stille Woning 386, Waterval 384, Navarre 383, Fransfontein Reserve 6, Smalruggens 684, Remainder of Aub 683, Portion 1 of Aub 683, Spitskop 678, Annabis 677, Portion 1 (Noukloof) of Engelbrecht 272, Remainder of Engelbrecht 272, Remainder of Brambach 271, Portion 1 of Brambach 271, Portion 1 of the farm Amkarub 269, Portion 2 (Sonernaam) of the farm Amkarub 269, the farm Kakatswa Onguati 236, Anker 602, Dwars-Trek 611, Deo Volento 610, Emmanuel 613, Condor 617, Waterbron 623, Quo Vadis 625 and Remainder of Marienhöhe 639, to the north-eastern corner beacon of last-mentioned farm; thence in an easterly, northerly, westerly northerly and generally easterly direction along the boundaries of the following farms so as to include them in this area: Wildeck 626, Arendsnes 627, Blyerus 628, Kaross 237, Robyn 647, Ermo 646, Robyn 647, Pioneer 648, Helaas 649, Vlakwaer 652, Grenswag 655, Farm 656, Seringetti 659, Leeurante 660, Sonderwater 420, Safari 663, Moesamoeroep 421, Volouiga 424, Willina 427, Stillerus 694, Avondvrede 430, Burgershof 432, Sonop 434, Tiervlei 436, Margo 438, Leeupoort 441, Farm 456, Oberland 455, Koppies 457, Mooiplaas 462, Elandsfontein 463, Nuchas 468, Werda 469, Tsabis 470, Grensplaas 473 and Renex 494, to the north eastern corner beacon of the farm Monty 329, the point of the beginning.”;

Name of district: Khorixas.

Name of place specified as the seat of magistracy for the district: Khorixas. The local limits of the Magisterial District of Khorixas shall be defined as follows:

From a point where the middle of the Hoanib river intersects the coastline of the Atlantic Ocean; thence north-eastwards along the said middle of the Hoanib River to a point where it intersects the south-western boundary of Sesfontein Reserve 207; thence along the southern boundary of the said Sesfontein Reserve 207 so as to exclude it from the area, to a point where the south-eastern boundary thereof intersects the middle of the Hoanib River; thence generally south-eastwards along the said middle of the Hoanib River up to its confluence with the Ombonde River; thence along the middle of the said Ombonde River to a point where it intersects the north-western boundary of Farm 621 (approximately 2 000 meters from its westernmost corner beacon); thence generally northwards and eastwards along the boundaries of the following farms so as to include them in this area: the said Farm 621, Remainder of Kamdescha 624, Portion 1 of Kamdescha 624, De Ville 638, Marenphil 641, Westend 642, Remainder of Tevrede 643, and Farm 644, to the north-eastern corner beacon of Farm 644; thence generally southwards and south-westwards along the boundaries of the following properties so as to include them in this area: the farms Farm 644, Farm 645, Swartskamp 640, Marienhöhe 639, Quo Vadis 625, Waterbron 623, Condor 617, Emmanuel 613, Deo Volento 610, Dwars-trek 61, Anker 602, Kakatswa Onguati 236, Portion 2 (Sonernaam) of Amkarub 269, Portion 1 of Amkarub 269, Portion 1 of Brambach 271, Remainder of Brambach 271, Remainder of Engelbrecht 272, Portion 1 (Noukloof) of Engelbrecht 272, Annabis 677, Spitskop 678, Portion 1 of Aub 683, Remainder of Aub 683, Smalruggens 684, Fransfontein Reserve 6, Navarre 383, Waterval 384, Stille Woning 386, Braunfels 387, Farm 388, Renosterkop 389,

Löwenfontein 84, to the easternmost corner beacon of the last-mentioned farm; thence along the southern boundary of the farm Löwenfontein 84 to a point where it intersects the middle of the Ugab river; thence in a generally south-westerly and westerly direction along the middle of the said Ugab river to a point where it intersects the coastline of the Atlantic Ocean; thence along the said coastline in a northerly direction to a point where it intersects the middle of the Hoanib river, the point of the beginning.”;

**“ANNEXURE T- OPUWO**

Name of district: Opuwo

Name of place specified as the seat of magistracy for the district: Opuwo. The local limits of the Magisterial District of Opuwo shall be defined as follows:

From a point where the +100 600 meter y-co-ordinate line on the LO 22/13-trigonometrical survey system intersects the middle of the Kunene River; thence eastwards along the said middle up to a point at the Ruacana Falls above the crest or lip where the said middle intersects the parallel of latitude 17°23'24" south; thence in a grid direction 270°00'00" to the Ruacana Rest Camp at approximate co-ordinates Y+83 000 and X-508 000, excluding the rest camp; thence in a southerly, south-westerly, southerly, south-easterly, southerly and south-westerly direction along the middle of a road to the Ombarundu Border check point, at approximate co-ordinates Y+90 600 and X-461 700, to include Ombarandu; thence in a general south-easterly direction for approximately 33 kilometers along the middle of a road to the Ombombo Border check point at approximate co-ordinates Y +76 000 and X-442 000; thence in a southerly direction along the middle of the Ruacana-Kamanjab main road to a point where it intersects with the northern boundary of the farm Kowares 276; thence along the northern and eastern boundaries of the said farm Kowares 276 and in a straight line in a southerly direction to the north-eastern corner beacon of the farm Tevrede 643; thence generally westwards and southwards along the boundaries of the following farms so as to exclude them from this area: Tevrede 643, Westend 642, Marenphil 641, De Ville 638, Kamdescha 624 and Farm 621 to a point where the middle of the Ombonde river intersects the north-western boundary of the last-named farm (approximately 2 000 meters from the westernmost corner beacon thereof); thence generally north-westwards along the middle of the said Ombonde river up to its confluence with the Hoanib River; thence generally north-westwards along the middle of the last-mentioned river to a point where it intersects the south-eastern boundary of Sesfontein Reserve 207; thence along the southern boundary of the said Sesfontein Reserve 207 so as to include it in this area, to a point where the middle of the Hoanib River intersects the south-western boundary of Sesfontein Reserve 207; thence south-westwards along the middle of the Hoanib River to a point where the middle of the Hoanib River meets the coastline of the Atlantic Ocean; thence generally north-westwards along the said coastline to a point where the middle of the Kunene River meets the coastline of the Atlantic Ocean; thence eastwards along the middle of the said river to a point where the +100 600 meter y-co-ordinate line on the LO 22/13 -trigonometrical survey system intersects the middle of the Kunene river, the point of the beginning.”;

**“ANNEXURE U- UUTAPI**

Name of district: Uutapi.

Name of place specified as the seat of magistracy for the district: Uutapi. The local limits of the Magisterial District of Uutapi shall be defined as follows:

Beginning at a point at the Ruacana Falls above the crest or lip where the middle of the Kunene River intersects the parallel of latitude 17°23'24" south, in a general easterly direction along the said border to a point where it intersects the middle of the Shakambebe Oshana; thence in a general southerly direction along the middle of the said Oshana to a point with system 22/15 co-ordinates Y -69 500 and X -479 00; thence in a general south-westerly direction in a straight line to a point where the middle of the Etaka Oshana intersects the line of latitude 18°02'00" S, thence in a general south-easterly direction along the middle of the last-mentioned Oshana to a point where the line of latitude 18°09'00" S intersects with the line of longitude 15°30'00" E; thence in a southerly direction in a straight line to a point where the line of latitude 18°39'00" S intersects with the line of longitude 15°34'00" E on the northern boundary of the Etosha National Park; thence in a general westerly direction along the said boundary to a point in the middle of a road at approximate co-ordinates Y-57 000 and X-368 000; thence in a general south-westerly direction along the middle of the said road to a T-junction at approximate co-ordinate X-358 500; thence along the middle of the road in a general south-easterly, southerly and south-westerly direction to a T-junction at approximate co-ordinate X-331 400; thence in a south-easterly direction along the middle of the Otjovasandu-Okaukuejo road to a T-junction at approximate co-ordinate U-63 500; thence along the middle of the road in a general westerly direction to a T-junction at approximate co-ordinate U-33 500; thence in a general southerly direction along the middle of the road to the north-eastern corner beacon of the farm Safari 663; thence in a westerly, southerly, easterly southerly, westerly and northerly direction along the southern and western boundaries of the Etosha National Park; thence in a general northerly direction along the middle of the Ruacana -Kamanjab main road to a point where this road intersects the southern boundary to the farm Kowares 276, thence along the southern, eastern and northern boundaries of the said farm Kowares 276, so as to exclude it from this area; thence in a general northerly direction along the middle of the Ruacana-Kamanjab main road to the Ombombo Border check point at approximate co-ordinates U+76 000 and X-442 000; thence in a general north-westerly direction along a road for approximately 33 kilometers to the Ombarandu Border check point at approximate co-ordinates Y+90 600 and X-461 700; thence along the middle of a road in a north-easterly, northerly, north-westerly, northerly, north-easterly and northerly direction to the Ruacana Rest Camp at approximate co-ordinates U+83 000 and X-508 000; thence in a grid direction 90°0'00" to a point in the middle of the Kunene River at co-ordinate X-508 000; thence in a northerly direction along the middle of the said river to the point of beginning.”;

**“ANNEXURE W- ONDANGWA**

Name of district: Ondangwa.

Name of place specified as the seat of magistracy for the district: Ondangwa. The local limits of the Magisterial District of Ondangwa shall be defined as follows:

Beginning at a point on the northern boundary of the Etosha National Park with co-ordinates U -57 000 and X -368 000; thence northwards in a straight line to a point where the meridian of longitude  $15^{\circ}45'$  east intersects the parallel of latitude  $18^{\circ}$  south; thence eastwards in a straight line to where the parallel of latitude  $18^{\circ}$  south intersects the meridian of longitude  $15^{\circ}50'$  east; thence northwards in a straight line to a point where the parallel of latitude  $17^{\circ}41'20''$  south intersects with longitude  $15^{\circ}50'$  east; thence eastwards in a straight line to where the parallel of latitude  $17^{\circ}41'20''$  south intersects the meridian of longitude  $16^{\circ}$  east; thence southwards in a straight line to the north-eastern corner beacon of the farm Ondangwa Town and Townlands 882; thence southwards along the boundary of, and including the said farm to the south-eastern corner beacon of that farm; thence southwards in a straight line to a point where the parallel of latitude  $18^{\circ}01'$  south intersects the meridian of longitude  $16^{\circ}$  east in the middle of a road running in a south-western to north-eastern direction; thence generally north-eastwards along the middle of the said road for approximately two kilometers to a point where it intersects a road running in a northern to southern direction at the intersection of the parallel of latitude  $18^{\circ}01'10''$  south and the meridian of longitude  $16^{\circ}00'45''$  east; thence generally southwards along the middle of the last-mentioned road to the trigonometrical beacon Okaruku No. 156 at the intersection of the parallel of latitude  $18^{\circ}13'20''$  south and the meridian of longitude  $16^{\circ}01'30''$  east; thence generally south-westwards along the middle of the said road to a point where the parallel of latitude  $18^{\circ}18'30''$  south intersects the meridian of longitude  $15^{\circ}57'$  east; thence generally southwards along the middle of the said road to a point where the -101350 meter y-co-ordinate line intersects the -400000 meter x-co-ordinate line on the LO 22/15 trigonometrical survey system; thence westwards in a straight line to a point where the -400000 meter x-co-ordinate line on the said survey system intersects the middle of the Ekuma Oshana; thence generally southwards along the middle of the said Oshana to a point where it drains into the Etosha pan with system 22/17 at approximate co-ordinate Y+102 500; thence in a south-westerly, southerly and south-easterly direction along the western edge of the Etosha Pan to its intersection with a road with system 22/15 at approximate co-ordinate U-102 200; thence in a southerly direction along the middle of the said road, until its intersection with the Halali-Okaukuejo main road; thence in a westerly direction along the middle of the last-mentioned road, including Okaukuejo into the region; thence in a southerly direction along the middle of the Okaukuejo-Outjo main road until its intersection with the southern boundary of the Etosha National Park; thence westwards and northwards along the southern boundary of the said Park up to the north-eastern corner beacon at the Farm Safari 663; thence in a northerly direction along a road to a T-junction with approximate co-ordinate Y-33 500; thence in an easterly direction along the fork to a T-junction with the Otjovasandu-Okaukuejo road with approximate co-ordinate Y -63 500; thence in a north-westerly direction along the road to a T-junction with co-ordinate X-331 400; thence in a north-easterly, northerly and north-westerly direction to a T-junction with approximate co-ordinate X-358 500; thence in a general northerly direction along the road to a point on the northern boundary of the Etosha National Park with co-ordinates Y-57 000 and X -368 000, the point of the beginning.”;

Name of district: Tsumeb

Name of place specified as the seat of magistracy for the district: Tsumeb. The local limits of the Magisterial District of Tsumeb shall be defined as follows:

From a point where the meridian of longitude 18° east intersects the northern boundary of the farm Last Hope 880; thence generally eastwards along the boundaries of, and including the farms Last Hope 880, Remainder of Wildernis 882, Randeier 1062 and Farm 1061, to the easternmost corner beacon of the last-mentioned farm; thence generally in a southerly direction along the boundaries of the following properties so as to include them in this area: Farm 1061, Driehoek 883, Choantsas 292, Remainder of the Pennys 826, Portion 1 (Panorama) of Bethanie 837, Portion 2 of Bethanie 837, Remainder of Bethanie 837, Cork 696, Cuxhaven Oos 1278, Neu Brisbane 1232, Bombay 670, Boston 1259, Bremen 672, Bergen 668, Batavia 667, Castries 680, Cherboury 681, Remainder of Nosib Block III 655 and Portion 5 of Nosib Block 111 655, to the south-eastern corner beacon of the last-mentioned farm; thence generally in a western direction along the boundaries of the following properties so as to include them in this area: Portion 5 of Nosib Block III 655, Chaub 47, Chaub West 590, Mosbach 589, Emilienhof 588, Tanto Uberior 785, Danevis Nord 48, Wa Iroda 546, Neuhorst Nord 475, Vogelberg 463, Wandelberg 462, Seringboom 460, Grasvlakte 457, Guinas Weide 456, Portion 2 of Guinas 454, Guinas Vlei 1126, Portion 2 of Guinas 454, Farm 843, Ventersville 855, Kroonhof 1064, Remainder of Haloli 860, Kalkbank 1234 and Portion 1 of Heliodor 857, to the southern-western corner beacon of the last-mentioned farm; thence generally in a north-westerly direction along the boundaries of the following properties so as to include them in this area: Portion 1 of Heliodor 857, Nadubib 1083, Farm 858, Leeudrink 940, Remainder of Kleinbegin 941, Vergenoeg 942 and Onguma 314, to the north-western corner of the last-mentioned farm; thence in an easterly direction along the northern boundary of the said Onguma 314 to a point where the fence of the Etosha National Park meets the farm boundary; thence in a south-westerly and westerly direction along the eastern and southern boundaries of the Etosha National Park until its intersection with the Okuakuejo-Outjo main road; thence in a northerly direction along the middle of the said main road, to exclude Okuakuejo from this area; thence in an easterly direction along the middle of the Halali-Okuakuejo main road to a T-junction with system 22/15 co-ordinate Y -100 400; thence in a northerly direction along the middle of the road to its intersection with the Etosha Pan at approximate co-ordinate Y -102200; thence in a north-westerly, northerly and north-easterly direction to a point with system 22/17 approximate co-ordinate U+100000, where the Ekuma Oshana drains into the Etosha Pan; thence northwards along the middle of the said Oshana to a point where it intersects the -400000 metre x-co-ordinate line on the LO 22/15-trigonometrical survey system; thence eastwards in a straight line to a point where the -101350 metre y-co-ordinate line intersects the -400000 metre x-co-ordinate line on the said survey system in the middle of a road running in a northern and southern direction; thence generally northwards along the middle of the said road to a point where the parallel of latitude 18°18'30" south intersects the meridian of longitude 15°57' east; thence generally north-eastwards along the middle of the said road to the trigonometrical beacon Okaruku No. 156 at the intersection of the parallel of latitude 18°13'20"



south and the meridian of longitude  $16^{\circ}01'30''$  east; thence generally northwards along the middle of the said road to a point where it intersects the middle of a road running in a south-western and north-eastern direction at the intersection of the parallel of latitude  $18^{\circ}01'10''$  south and the meridian of longitude  $16^{\circ}00'45''$  east; thence generally south-westwards along the middle of the last-mentioned road for approximately two kilometres to a point where the parallel of latitude  $18^{\circ}01'$  south intersects the meridian of longitude  $16^{\circ}$  east; thence northwards in a straight line to the south-eastern corner beacon of the farm Ondangwa Town and Townlands 882; thence northwards along the boundary of, and excluding the said farm to the north-eastern corner beacon of that farm; thence northwards in a straight line to a point where the parallel of latitude  $17^{\circ}41'20''$  south intersects the meridian of longitude  $16^{\circ}$  east; thence generally south-eastwards in a straight line to a point where the parallel of latitude  $17^{\circ}56'$  south intersects the meridian of longitude  $16^{\circ}22'$  east; thence generally north-eastwards in a straight line to a point where the parallel of latitude  $17^{\circ}46'$  south intersects the meridian of longitude  $16^{\circ}45'20''$  east; thence generally eastwards in a straight line to a point where the parallel of latitude  $17^{\circ}45'$  south intersects the meridian of longitude  $18^{\circ}$  east; thence southwards along the meridian of longitude  $18^{\circ}$  east to a point where it intersects the northern boundary of the farm Last Hope 880, the point of the beginning.”;

**“ANNEXURE Z- RUNDU**

Name of district: Rundu

Name of place specified as the seat of the magistracy for the district: Rundu. The local limits of the Magisterial District of Rundu shall be defined as follows:
