ALTERATION OF THE BOUNDARIES OF THE MUNICIPALITY OF WALVIS BAY

Under the powers vested in me by section 4(1)(b) of the Local Authorities Act, 1992 (Act No. 23 of 1992) I hereby alter the boundaries of the Municipality of Walvis Bay by the addition of certain areas thereto.

The boundaries of the Municipality of Walvis Bay shall be as set out in the Schedule.

This description of the boundaries of the Municipality of Walvis Bay is in substitution of the description referred to in paragraph (a) of Proclamation No. 16 of 1994.

SCHEDULE

Beginning at a point where the northern boundary of Farm 48 intersects the high-water mark of the Atlantic Ocean; thence eastwards, southwards, then generally southwards along the boundaries of and including the following properties, namely Farm 48, Farm 42, Farm 47, Farm 44, Farm 36, and Farm 46 where the south-eastern corner beacon of Farm 46 intersects Farm 39; thence eastwards, southwards and south-westwards along the boundaries of and including the Farm 39 to the south-easternmost corner beacon of the farm Wanderdünen 23; thence generally south-westwards along the boundaries of the farm Wanderdünen 23 to the northernmost corner beacon of Farm 38; thence generally south-eastwards along the boundaries of and including Farm 38 to the south-easternmost corner beacon of Farm 38 numbered RB 6 (Diagram A72/73) where it intersects the farm Skietbaan 29; thence generally westwards, northwards along the boundaries and including the following properties, namely Farm 38, Farm 37, Farm Fertilis 24, Farm Narras 25, Farm Dünen 26, Farm Lac Fundus 27 and Farm 37 to the south-western corner beacon numbered TB 7804 (Diagram A67/67) of Farm 33; thence eastwards, northwards, westwards along the boundaries of and excluding Farm 33 to the north-western corner beacon numbered TB 7801 (Diagram A67/67) of Farm 33; thence generally north-westwards along the boundary of and including Farm 38 to the north-western corner beacon numbered 38 F13 (Diagram 72/73) of Farm 38 where it intersects the southern boundary of the farm Wanderdünen 23; thence south-westwards, north-westwards, along the boundaries of and including the Farm Wanderdünen 23, Remainder of Portion B of the farm Walvis Bay Town and Townlands No. 1 to the north-western corner beacon numbered TC 2 (Diagram A121/31); thence generally north-westwards along the boundaries of and including the Remainder of Portion B of the farm Walvis Bay Town and Townlands No.1 to the south-western corner beacon of Farm 45 numbered B (Diagram SG630-94); thence along the boundaries of and including Farm 45 to the south-eastern corner beacon of Farm 45 numbered A (Diagram SG630-94) and 94Q (Diagram A107/70); thence generally north-eastwards along the boundaries of and including Portion 94 (a portion of Portion B) of the farm Walvis Bay Town and Townlands No.1 to beacons numbered TC 1 and C (Diagram A121/31); thence in a series of straight lines connecting beacons C, W6, W5, W4, (Plan F29 A539/61) and beacons W4N, HW1, HW2, HW3, HW4, and HW5, (Diagram A419/97) to include Farm 50; thence from HW5 along the high-water mark and including the following erven, namely 2033 (street) (a portion of consolidated Erf 1920), Remainder of Consolidated Erf 1920, Erf 1240, Erf 1909, Portion A of Erf 283, Portion 3 of Erf 283, Erf 1236, Erf 3004, Erf 3537, Remainder of Erf 1237, Erf 3534, Erf 3615, Erf 3685, Erf 3686, Erf 3687, Erf 3688, Erf 3689, Erf 3690, Erf 3618, Erf 3614, Erf 3691, Erf 3692, Erf 3693 to the south-western corner beacon of Erf 3701; thence in a north-western then north-eastern direction along the high-water mark and including Erf 3701, Erf 3696, Erf 3612, Erf 3611, Erf 3610, Erf 3619, Erf 3620 and from this point in a generally northerly direction along the high-water mark to the south-western corner beacon of Farm 36 numbered 36G (Diagram A272/72) to include Farm 39 and Farm 46; thence in a series of straight lines connecting beacons 36G, 36A, 43F, high-water mark (Diagram A5584/90) to include Farm 36 and Farm 44; thence from this point (high-water mark) in a generally northerly direction along the high-water mark to include Farm 44, Farm 47, Farm 42, Farm 48 to the point of beginning. Also including the detached Farm 43.
