DECLARATION OF MEMBERS OF REGIONAL COUNCILS AS
OFFICE-BEARERS FOR THE PURPOSES OF THE MEMBERS OF THE
NATIONAL ASSEMBLY AND OTHER OFFICE-BEARERS PENSIONS ACT, 1990

Under section 1(2) of the Members of the National Assembly and other Office-bearers Pensions Act, 1990 (Act No. 21 of 1990) and for the purposes of the said Act, I hereby declare as Office-bearers all persons who were elected as members of Regional Councils during the period extending from 30 November 1992 to the date immediately prior to the commencement of the Members of Parliament and other Office-bearers Act, 1999 with effect from their respective dates of election as such members.
