**BY-ELECTION FOR A REGIONAL COUNCIL MEMBER IN WINDHOEK-WEST
CONSTITUENCY: DETERMINATION OF DAY AND PLACE FOR SUBMISSION
OF NOMINATIONS OF CANDIDATES AND POLLING DAY: ELECTORAL
ACT, 1992**

Under the powers vested in me by subsection (1) of section 50 of the Electoral Act, 1992 (Act No. 24 of 1992), it is hereby made known that I have under that subsection determined -

- (a) Wednesday, 29 August 2003, as the day on which a public sitting shall be held for the submission of nominations of candidates for election as member of the regional council in respect of the Windhoek-West Constituency, and that it must be held from 09h00 until 11h00 at the Office of the Electoral Commission of Namibia, Windhoek; and

- (b) that, if a poll becomes necessary for the reason that more than one person have been duly nominated at the close of the public sitting referred to in paragraph (a), the poll shall be taken on 30 September 2003, from 07h00 until 21h00.
