PROPOSED AMENDMENT TO PART 187 OF NAMIBIA CIVIL AVIATION REGULATIONS, 2001

Pursuant to the provisions of regulation 11.03.2 of the Namibia Civil Aviation Regulations, 2001 the Director: Civil Aviation hereby invites all interested parties to comment on the proposed amendment to Part 187 of the said regulations.

(1) If a staff member in the service of the Ministry incurs any additional expenses relating to travel and subsistence in order to adjudicate any application made, or with a view to adjudicating any application to be made, in terms of the Regulations, the applicant shall be liable for such additional expenses, calculated in accordance with paragraph D iii/ii of the Public Service Staff Rules.
