The point of beginning is at the co-ordinates of point 1, which point is the most northern point on the boundary of the Conservancy, at Ibolokwa on the Zambezi River (see table below). From this point the boundary runs in a south-westerly direction until it reaches point 2. From this point the boundary runs in a general south-easterly direction through points 3 to 5 to point 6, then in a general south-westerly direction through points 7 to 18 to point 19, then in a general south-easterly direction through points 20 to 22 to point 23. From this point the boundary runs in a general easterly direction through points 24 to 25 to point 26, then in a south-easterly direction to point 27, then in a general north-easterly direction through points 28 to 30 to point 31. From this point the boundary continues to run in a south-easterly direction through point 32 to point 33 on the Chobe River. From this point the boundary follows the Chobe River, along the border between Namibia and Botswana, in a general westerly direction and then in a general north-westerly direction until it reaches point 34 where the Mukololo stream meets the Chobe River. From this point the boundary follows the Mukololo stream in a general north-westerly direction through points 35 to 46 to point 47 where the Mukololo stream flows through a small lake, Lyankunga, until it reaches point 48, then in a general westerly direction through point 49 to point 50 at Sigwe village. From this point the boundary continues to follow the Mukololo stream in a general north-westerly direction through point 51 to point 52, then in a general north-easterly direction through points 53 and 54 to point 55. From this point the boundary runs in a north-easterly direction through points 56 and 57 to point 58 at Kayanga village, then it runs in an easterly direction through points 59 and 60 to point 61. From this point the boundary runs in a southerly direction to point 62, then in a north-easterly direction until it reaches the point of beginning, point 1.
