AMENDMENT TO THE NAMIBIAN CIVIL AVIATION REGULATIONS, 2001: AVIATION ACT, 1962

The Minister of Works, Transport and Communication has under section 22 of the Aviation Act (Act No. 74 of 1962) after consultation with the Minister of Finance made the regulations set out in the Schedule.

SCHEDULE

1. In these regulations, “the Regulations” means “Namibian Civil Aviation Regulations” promulgated under Government Notice No. 1 of 2 January 2001.
