#### APPLICATIONS FOR REGISTRATION OF TRADE MARKS IN NAMIBIA

Failing such notice to the applicant an opponent may not succeed in obtaining an order for costs.

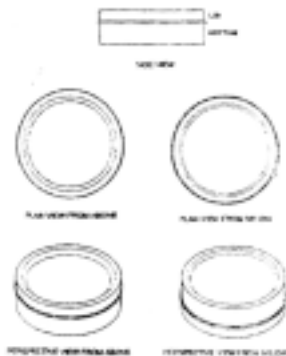
