**DECLARATION OF PEACE OFFICERS IN TERMS OF SECTION 334 OF THE
CRIMINAL PROCEDURE ACT, 1977 (ACT NO. 51 OF 1977)**

Under section 334 of the Criminal Procedure Act, 1977 (Act No. 51 of 1977), I

- (a) under subsection (1) of that section, declare that every person who, by virtue of his or her office, falls within the category defined in column 1 of the Schedule below, may within the local authority area specified in column 2 of the Schedule, be a peace officer for the purpose of exercising, with reference to the offences specified in column 3 of the Schedule, the powers defined in column 4 of the Schedule;
- (b) under paragraph (b) of subsection (3) of that section, prescribe that the following must appear on the certificate of appointment referred to in subsection (2) of that section, issued to any person referred to in column 1 of the Schedule, namely:
 - (i) the full name of the person appointed;
 - (ii) his or her identity number;
 - (iii) his or her signature;
 - (iv) his or her photograph;
 - (v) a description of the capacity in which he or she was appointed;
 - (vi) the name of the local authority council which, subject to the approval of the Minister of Transport and Communication, made the appointment; and

- (vii) the signature and official stamp of the employer or responsible person;
- (c) under paragraph (a) of subsection (3) of that section prescribe, that a certificate of appointment, referred to in subsection (2) of that section, may only be issued by the council of the corresponding local authority referred to in column 2 of the Schedule after that council has been furnished with a certificate issued by the Inspector General of the Namibian Police stating that in the Inspector General's opinion such person is competent to exercise the powers defined in column 4 of the Schedule; and
- (d) amend Part 5(f) of the Schedule to Government Notice No. R159 of 2 February 1979 by the deletion -
- (i) of the category of persons defined in column 1 of that Schedule;
- (ii) of the area specified in column 2 of that Schedule;
- (iii) of the offences referred to in column 3 of that Schedule; and
- (iv) of the powers defined under column 4 of that Schedule.

4. Minimum qualifications required to qualify for allotment

An applicant (other than a company or close corporation contemplated in section 41(7) of the Agricultural (Commercial) Land Reform Act, 1995 (Act No. 6 of 1995) must be a Namibian citizen who -

- (a) is 18 years of age or older;
- (b) has a background or interest in agriculture or related enterprises;
- (c) has been socially, economically, or educationally disadvantaged by past discriminatory laws or practices;
- (d) has relinquished any right in respect of agricultural land;

5. Rent payable in respect of farming units

A farming unit is to be leased for 99 years. The approximate rent payable in respect of a farming unit so leased for livestock farming, shall be determinate by the Minister, on the recommendation of the commission, based on the value of the farming unit.

6. Lease Agreement

A successful applicant must enter into a lease agreement with the Minister of Lands and Resettlement.
