CODE OF CONDUCT GOVERNING PERSONS ACCREDITED TO PROVIDE VOTER EDUCATION FOR OR IN RESPECT OF ELECTIONS: ELECTORAL ACT, 1992

Under section 47B of the Electoral Act, 1992 (Act No. 24 of 1992), the Electoral Commission hereby issues a Code of Conduct Governing Persons Accredited to Provide Voter Education for or in Respect of Elections as set out in the Schedule.

SCHEDULE

CODE OF CONDUCT GOVERNING PERSONS ACCREDITED TO PROVIDE VOTER EDUCATION FOR OR IN RESPECT OF ELECTIONS

1. Every person accredited to provide voter education must -
 - (a) inform and make voters aware of their protected right to freedom of conscience and belief, freedom of speech and expression, freedom of association and peaceful assembly, freedom of movement and of the right to participate freely in peaceful political activities;
 - (b) respect the right of voters to elect a party, organisation, association or candidate of their choice by using an impartial training method;
 - (c) ensure that voters are informed and made aware thereof that political parties, organisations, associations, candidates and the media are free to impart information and opinion;
 - (d) always act in a non-partisan manner and be free of any influence or control by any political party, organisation, association or candidate;
 - (e) strive to promote democratic pluralism and a culture of political tolerance;
 - (f) keep such books of account as are reasonably necessary;
 - (g) use funds received for voter education only for the purpose for which it was appropriated;
 - (h) act in a strictly neutral and unbiased manner in every matter concerning a political party, organisation, association, candidate or voter; and
 - (i) avoid doing anything that would indicate or be seen as indicating partisan support for a political party, organisation, association or candidate.
2. A person accredited to provide voter education may not -
 - (a) misuse any funds received for the purpose of voter education;

- (b) ascertain or attempt to ascertain for which political party, organisation, association or candidate any voter intends to vote;
- (c) induce, influence, persuade or procure a voter to register for or vote in an election, in the knowledge that such voter is not entitled to register or vote in the election concerned;
- (d) influence or attempt to influence the choice of a voter regarding any political party, organisation, association or candidate in an election;
- (e) publish, repeat or disseminate in any manner whatsoever false information;
- (f) obstruct or interfere with the work of any official or representative or the Commission;
- (g) accept any gift or favour from a political party, organisation, association, a candidate or any person involved in the election process; and
- (h) wear, carry or display any symbol or colour of any political party, organisation, association or candidate.

CODE OF CONDUCT GOVERNING ACCREDITED OBSERVERS AND PERSONS APPOINTED BY ACCREDITED OBSERVERS: ELECTORAL ACT, 1992

Under section 52A(3) of the Electoral Act, 1992 (Act No. 24 of 1992), the Electoral Commission hereby issues a Code of Conduct Governing Accredited Observers and Persons Appointed by Accredited Observers as set out in the Schedule.

SCHEDULE**CODE OF CONDUCT GOVERNING ACCREDITED OBSERVERS AND PERSONS APPOINTED BY ACCREDITED OBSERVERS**

1. Every accredited observer and every person appointed by an accredited observer must -
 - (a) observe any election concerned impartially and independently of any political party, organisation, association or candidate contesting the election;
 - (b) remain non-partisan, neutral and unbiased in respect of the election concerned;
 - (c) be competent and professional in observing the election concerned;
 - (d) provide the Commission with a comprehensive review of the election concerned, taking into account all relevant circumstances including -
 - (i) the degree of impartiality shown by the Commission;
 - (ii) the degree of freedom of political parties, organisations, associations or candidates to organise, move, assemble and express their views publicly;
 - (iii) the opportunity for political parties, organisations, associations or candidates to have their agents observe all aspects of the electoral process;
 - (iv) the fairness of access for political parties, organisations, associations and candidates to national media and other resources of the state;
 - (v) the proper conduct of polling and counting of votes; and
 - (vi) any other issue that concerns the essential freedom and fairness of the election concerned;
 - (e) comply with all instructions given and every obligation imposed by -
 - (i) the Commission;
 - (ii) any person in the performance of his or her duties or functions or the exercise of his or her powers under this Act;
 - (iii) any employee or officer of the Commission; or
 - (iv) any person performing security services on the instruction of any employee or officer of the Commission.

2. Every accredited observer and every person appointed by an accredited observer -
 - (a) must avoid doing anything that would indicate or be seen as indicating partisan support for a political party, organisation, association or candidate;
 - (b) must disclose to the Commission any relationship that could lead to a conflict of interest regarding the performance of their duties as observers or with the process of observation or assessment of the election concerned;
 - (c) may not accept any gift or favour from a political party, organisation, association, candidate or person involved in the election process;

- (d) may not participate in any function or activity that could lead to a perception of sympathy for a particular political party, organisation, association or candidate
- (e) may not express a view or opinion on any matter which is the subject of electoral campaigning;
- (f) may not influence or attempt to influence the choice of a voter regarding any political party, organisation, association or candidate in an election; and
- (g) may not wear, carry, or display any symbol or colour of any political party, organisation, association or candidate.
