AMENDMENT OF REGULATIONS MADE UNDER POLICE ACT, 1990

SCHEDULE

Definitions

1. In these regulations “the Regulations” means the Regulations published under Government Notice No. 167 of 16 September 1994, as amended by Government Notices Nos. 143 of 15 June 1996, 246 of 01 October 1998, 166 of 01 August 2001 and 55 of 02 April 2002.

Substitution of Schedule C of Regulations

2. The following Schedule is substituted for Schedule C of the Regulations:

 - (i) General Staff:
 - General;
 - Lieutenant-General;
 - Major-General;
 - Commissioner;
 - (ii) Senior Commissioned Officers:
 - Deputy Commissioner;
 - Assistant Commissioner;
 - Chief Inspector;
 - (iii) Junior Commissioned Officers:
 - Assistant Chief Inspector;
 - Inspector;
 - Assistant Inspector;
- (b) Non-Officers:
 - (i) Warrant Officer (1);
 - (ii) Warrant Officer (2);
 - (iii) Sergeant (1);
 - (iv) Sergeant (2)
 - (v) Constable; and
 - (vi) Cadet Constable.”.

Substitution of Schedule D of Regulations

3. The following Schedule is substituted for Schedule D of the Regulations:

“SCHEDULE D
(Regulation 28(1))

BADGES, BUTTONS AND INSIGNIA OF RANK

- 1. Badges:
 - (a) A twelve-point sun, in the centre of which appears the coat-of-arms of the Republic of Namibia within a circle. The words “Namibian Police” appear as circumscription on the rim of the circle, above the coat-of-arms.

- (b) A shoulder-flash depicting the National Flag of the Republic of Namibia. The words “Namibian” and “Police” appear above and below the flag, respectively, on the flash.

2. Buttons:

Dome-shaped, embossed with the badge as described in paragraph 1(a).

3. Insignia of rank:

| (d) | Commissioner | Crossed sword and baton, followed by a sun and a coat-of-arms within a laurel wreath; |
| (e) | Deputy Commissioner | Three suns in a triangle, followed by a coat-of-arms within a laurel wreath; |
| (f) | Assistant Commissioner | Two suns below a coat-of-arms within a laurel wreath; |
| (h) | Chief Inspector | A sun below a coat-of-arms within a laurel wreath; |
| (i) | Assistant Chief Inspector | A coat-of-arms within a laurel wreath; |
| (j) | Inspector | Three suns; |
| (k) | Assistant Inspector | Two suns; |
| (l) | Warrant Officer (1) | A Coat-of-arms within a laurel wreath; |
| (m) | Warrant Officer (2) | A sun within a laurel wreath; |
| (n) | Sergeant (1) | A three-bar chevron below a coat-of-arms within a laurel wreath; |
| (o) | Sergeant (2) | A three-bar chevron below a sun; |
| (p) | Constable | No insignia is allocated to this rank; |
| (q) | Cadet Constable | No insignia is allocated to this rank. |
