- a) The Council of the Namibia Qualifications Authority (NQA) accredits the courses offered in Windhoek at 170 Jan Jonker street leading to the following qualifications offered by the Industrial Craft Training Institute (ICTI):
- National Vocational Certificate in Automotive Engineering (Level 1) (Automotive Mechanics) (Q0018)

- National Vocational Certificate in Automotive Engineering (Level 2) (Automotive Mechanics) (Q0019)
 - National Vocational Certificate in Automotive Engineering (Level 3) (Automotive Mechanics) (Q0020)
 - National Vocational Certificate in Automotive Engineering Level 4) (Automotive Mechanics) (Q0021)
- b) The Council of the NQA accredits Industrial Craft Training Institute (ICTI) to offer its courses from the above site leading to the qualifications set out under paragraph (a).
- c) The period of accreditation extends until 10 November 2013.
- d) Industrial Craft Training Institute (ICTI) must apply for re-accreditation in terms of regulation 12(1) of the Regulations for the Accreditation of Persons, Institutions or Organisations promulgated under Government Notice No. 124 of 28 August 2006 in such time as to enable Council to make a decision prior to the 10 November 2013.
