4. Minimum qualifications required to qualify of applicants

An applicant, other than a company or close corporation contemplated in section 41(7) of the Agricultural (Commercial) Land Reform Act, 1995 (Act No. 6 of 1995) must be a Namibian citizen who -

- (a) is 18 years of age or older;
- (b) has a background or interest in agriculture or related activities;
- (c) has been socially, economically or educationally disadvantaged by past discriminatory laws or practices; and
- (d) has relinquished any right in respect of agricultural land.

5. Rent payable in respect of farming units

A farming unit is to be leased for a period of 99 years and the approximate rent payable in respect of a farming unit leased for livestock farming, is as determined by the Minister of Lands and Resettlement, on the recommendation of the Land Reform Advisory Commission, based on the value of the farming unit.

6. Lease Agreement

A successful applicant must enter into a lease agreement with the Minister of Lands and Resettlement.

Under section 17(1) of the Meat Industry Act, 1981 (Act No. 12 of 1981), I amend Government Notice No. 272 of 15 December 2010 by the substitution of the following item for item (b) of subparagraph 1.2:

"(b) the special meat classification levy is -

with effect from I January 2013 with effect from 1 July 2013

(i) N\$ 20.00 per cattle carcass; N\$ 22.00 per cattle carcass;

(ii) N\$ 4.00 per sheep or goat carcass; N\$ 4.40 per sheep or goat carcass; and

(iii) N\$ 6.00 per pig carcass N\$ 6.60 per pig carcass."

AMENDMENT OF REGULATIONS MADE UNDER MEAT INDUSTRY ACT, 1981

In terms of section 24 of the Meat Industry Act, 1981 (Act No. 12 of 1981), I have made the regulations as set out in the Schedule.

SCHEDULE

Definitions.

1. In these regulations, a word or expression to which a meaning has been assigned in the Act has that meaning, and unless the context otherwise indicates -

"levy" means a levy determined in terms of section 17 of the Act;

"the Regulations" means the Regulations published under Government Notice AG. 153 of 1 December 1981 as amended by Government Notice No. 126 of 21 September 1992;

"the Act" means the Meat Industry Act, 1981 (Act No. 12 of 1981).

Amendment of Regulation 2 of the Regulations

- **2.** Regulation 2 of the Regulations is amended -
- (a) by the substitution for subregulation (1) of the following subregulation:
 - "(1) The levy imposed under section 17(1) of the Act must be paid to the board by the fifteenth day of the month following the month in which the cattle, sheep, goats, pigs, meat or meat product concerned were sold, imported, exported or slaughtered.";
- (b) by the substitution for subregulation (2) of the following subregulation:
 - "(2) every payment of a levy referred to in subregulation (1) must be accompanied by a statement indicating -
 - (a) particulars of cattle, sheep, goats or pigs sold in Namibia;
 - (b) particulars of cattle, sheep, goats, pigs, meat or meat products imported into Namibia;
 - (c) particulars of cattle, sheep, goats or pigs exported from Namibia;
 - (d) particulars of cattle, sheep, goat or pigs slaughtered in Namibia;
 - (e) the value of each unit of cattle, sheep, goats or pigs and the value of each category of meat or meat product units in question."; and

(c) by the substitution for subregulation (5) of the following subregulation:

"(5) A person who pays a levy on behalf of another person must be paid by the board, a commission equal to 3% of such levy.".

THE RULES RELATING TO THE RECOGNITION OF A QUALIFICATION OBTAINED IN NAMIBIA AND THE REGISTRATION OF A PHARMACIST'S ASSISTANT: SECTION 20(3) OF THE PHARMACY ACT, 2004

Under section 20(3)(a) of the Pharmacy Act, 2004 (Act No. 9 of 2004), the Pharmacy Council of Namibia has made the rules set out in the Schedule.

THE PHARMACY COUNCIL OF NAMIBIA

SCHEDULE

Definitions

1. In these rules, unless the context otherwise indicates, a word or expression defined in the Act has that meaning, and -

"certified" means certified as a true copy of the original by a commissioner of oaths appointed under section 5, or designated under section 6, of the Justices of the Peace and Commissioners of Oaths Act, 1963 (Act No. 16 of 1963); and

"the Act" means the Pharmacy Act, 2004 (Act No. 9 of 2004).

The recognition of a pharmacist's assistant qualification obtained in Namibia

- **2.** For the purposes of paragraph (a) of subsection (3) of section 20 of the Act, any one of the following qualifications entitles the holder thereof to registration as a pharmacist's assistant:
 - (a) A Certificate in Pharmacy obtained at the National Health Training Centre of Namibia after the successful full time education, tuition and training at that Training Centre for a period of two years; or
 - (b) the successful completion of the first year of study, at an educational institution approved by the Council, for the purpose of obtaining a qualification in pharmacy which is prescribed as a qualification required for registration as a pharmacist.

Application for registration as a pharmacist's assistant and submitting of particulars

- **3.** (1) An application for the registration of a person as a pharmacist's assistant in accordance with section 20 of the Act must be -
 - (a) submitted to the registrar in the form determined and provided by the Council;
 - (b) accompanied by -
 - (i) a certified copy of the identity document or passport of the applicant;
 - (ii) documentary proof, to the satisfaction of the Council, that the applicant is the holder of -
 - (aa) a qualification in pharmacy contemplated in paragraph (a) of subsection (1) of section 20 of the Act; or

- (bb) any of the qualifications recognised by rule 2;
- (iii) additional documents and information that the Council may require; and
- (iv) payment of the fees determined by the Council relating to an application for registration as a pharmacist's assistant.
- (2) The Council may require the applicant to furnish, in the manner that the Council may determine, proof of the applicant's proficiency in the English language.
- (3) The Council, after having considered the application for registration, and the documents and other information referred to in subrule (1) -
 - (a) may grant the application for the registration of the applicant as a pharmacist's assistant if the Council is satisfied that the applicant -
 - (i) is the holder of any of the qualifications required for registration as a pharmacist's assistant specified by subparagraph (ii) of paragraph (b) of subrule (1);
 - (ii) has complied with subrule (1);
 - (iii) is a person referred to in paragraph (b) of subsection (2) of section 20 of the Act;
 - (iv) is proficient in the English language; and
 - (v) has paid to the Council the fees relating to the application;
 - (b) must refuse the application for the registration of the applicant as a pharmacist's assistant if the Council is satisfied that the applicant has not complied with all the requirements specified by paragraph (a).
 - (4) The Council must -
 - (a) inform the applicant in writing of the decision of the Council under subrule (3);
 - (b) issue, if the application for registration is granted under paragraph (a) of subrule (3), to the applicant a certificate of registration in the form that the Council may determine, and enter the name of the applicant into the register;
 - inform the applicant in writing, if the application for registration is refused under paragraph (b) of subrule (3), as soon as practicable of the grounds for the refusal.

Language of forms and documents

- **4.** (1) Subject to subrule (2), any form or document that must be submitted to the Council in terms of these rules must be in the English language.
- (2) Any form or document referred to in subrule (1) that is not in the English language must be accompanied by a sworn translation thereof into that language, acceptable to the Council.
