In terms of -

- (a) section 2(3) of the Community Courts Act, 2003 (Act No. 10 of 2003), I recognise the Kakuru-Kouye Customary Court as a community court in respect of the area of Kakuru-Kouye Traditional Community, and it -
  - (i) exercise jurisdiction over the districts set out in Part 1 of the Schedule; and

- (c) section 8(1) of that Act, I make known that I have in terms of that section appointed the persons whose names are specified in Part III of that Schedule as Justices to preside over the court recognised in terms of paragraph (a).
