**CALLING FOR REPRESENTATION IN OPPOSITION TO APPLICATION MADE TO
MINERALS ANCILLARY RIGHTS COMMISSION: MINERALS (PROSPECTING AND
MINING) ACT, 1992**

In terms of subsection (3) of section 109 of the Minerals (Prospecting and Mining) Act, 1992 (Act No. 33 of 1992), I publish and make known that -

- (a) the name of the holder of the non-exclusive prospecting licence, mineral licence or mining claim concerned set out in column 1 of the Table, with the type of licence set directly opposite the name in column 2 has applied to the Mineral Ancillary Rights Commission, the Commission, for the nature of the right required in column 3, with the description of the land in respect of which the said right is required as set out in column 4 of that Table;
