DESIGNATION OF AREAS IN RESPECT OF COMMUNAL AREA OF UKWANGALI TRADITIONAL COMMUNITY FOR GRANTING OF RIGHTS OF LEASEHOLD FOR AGRICULTURAL PURPOSES: COMMUNAL LAND REFORM ACT, 2002

In terms of section 30(2) of the Communal Land Reform Act, 2002 (Act No. 5 of 2002), 1, after consultation with the Ukwangali Traditional Authority and the Kavango East Communal Land Board, designate, in respect of the communal area of the Ukwangali Traditional Community, the area set out in the Schedule as the area within which the Kavango East Communal Land Board may grant rights of leasehold for agricultural purposes.
