#### DECLARATION OF NSI MARKS OF CONFORMITY: STANDARDS ACT, 2005

The Namibian Standards Institution (hereinafter referred to as the NSI) under section 21(1) of the Standards Act, 2005 (Act No. 18 of 2005), hereby declares the marks set out in the Schedule as NSI marks of conformity that may be applied to any commodity, system or document falling within the scope of a Namibian standard that has been set, established and issued under section 20 in respect of that commodity, system or document.

#### SCHEDULE

##### Declaration of NSI marks of conformity

1. (1) The following NSI Marks of conformity are declared:
  - (a) NSI standard mark of conformity;
  - (b) NSI Premium mark of conformity;

- (c) NSI NAMS/ISO 9001 certified firm mark of conformity;
  - (d) NSI NAMS/ISO 22000 certified firm mark of conformity;
  - (e) NSI NAMS/ISO 14001 certified firm mark of conformity; and,
  - (f) NSI certified person's certification mark of conformity.
- (2) The NSI marks of conformity as set out in subsection (1) are:
- (a) **NSI MARKS OF CONFORMITY - PREMIUM MARK**, Certifies that both the Product and Product Processing management system has been assessed and complies with the requirements of the applicable Namibian standards. The **PREMIUM MARK** is a mark of excellence awarded to manufactured products which have demonstrated high degree of excellence in manufacturing and quality.
  - (b) **NSI MARK OF CONFORMITY - STANDARD MARK**, Certifies that the Product has been assessed (sampled and tested) and complies with the requirements of the applicable Namibian Product Standard;
  - (d) **NSI MARK OF CONFORMITY - NSI CERTIFIED**, is a Mark of Conformity for a person who has been assessed and certified for compliance with the requirements of ISO/IEC 17024:2003 (or its latest version) in a specific industry sector.
  - (e) **NSI MARK OF CONFORMITY - NAMS/ISO 22000 CERTIFIED FIRM**, Certifies that the Food Safety Management System (FSMS) of an organisation has been assessed and complies with the requirements of NAMS/ISO 22000:2014 (or its latest version).
  - (f) **NSI MARK OF CONFORMITY - NAMS/ISO 14001 CERTIFIED FIRM**, Certifies that the Environmental Management System (EMS) of an organisation has been assessed and complies with the requirements of NAMS/ISO 14001:2014 (or its latest version).
  - (g) **NSI MARKS OF CONFORMITY - NAMS/ISO 9001 CERTIFIED FIRM**, Certifies that the Quality Management System (QMS) of an organisation has been assessed and complies with the requirements of NAMS/ISO 9001:2014 (or its latest version).
