- (a) For the election of a President, pursuant to Article 28 of the Namibian Constitution, read together with section 49(1)(a)(i) of that Act,
- (b) For the election of members of the National Assembly, pursuant to Article 46 of the Namibian Constitution, read with section 49(1)(b)(i) of that Act,

- (a) for the election of a President, pursuant to Article 28 of the Namibian Constitution, read with sections 49(1)(a)(i), 55(1) and 56 of that Act, I have determined 29 October 2014 as the date on which the submission of nominations of candidates for election to the office of the President takes place at a public sitting to be held by the Chairperson of the Electoral Commission at Elections House, 67-71 Van Rhijn Street, Windhoek-North, from 09h00 until 11h00; and
- (b) for the election of members of the National Assembly, pursuant to Article 46 of the Namibian Constitution, read with sections 49(1)(b)(i) and 59(1) of that Act, I have determined 29 October 2014 as the last day on which political parties that intend to participate in the election for members of the National Assembly must, not later than 11h00 on that day, submit a written list of candidates nominated with a view to filling of any seats in the National Assembly to which such political parties may become entitled, to the Electoral Commission at the Office of the Director of Elections, Elections House, 67-71 Van Rhijn Street, WindhoekNorth.
