**DESIGNATION OF REGIONAL COURT MAGISTRATES AS ELECTORAL  
TRIBUNALS AND APPOINTMENT OF DISTRICT MAGISTRATES  
AS PRESIDING OFFICERS: ELECTORAL ACT, 2014**

In terms of section 162 of the Electoral Act, 2014 (Act No. 5 of 2014), the Magistrates Commission, after consultation with the Electoral Commission of Namibia -

- (a) under subsection (1) of that section, designates every regional court magistrate of a regional division in which a constituency or local authority area is situated as electoral tribunal, or if a constituency or local authority area is situated in more than one regional division, the regional court magistrate of any of the divisions;
- (b) under subsection (3) of that section, appoints every district magistrate as presiding officer to preside over the electoral tribunal designated under paragraph (a) for a constituency or local authority area situated in his or her jurisdiction; and
- (c) repeals Government Notice No. 56 of 22 April 2014.
