PROCEDURE FOR ADVERTISING IN THE GOVERNMENT GAZETTE OF THE REPUBLIC OF NAMIBIA

1. The *Government Gazette* (Estates) containing advertisements, is published on every Friday. If a Friday falls on a Public Holiday, this *Government Gazette* is published on the preceding Thursday.

2. Advertisements for publication in the *Government Gazette* (Estates) must be addressed to the Government Gazette office, Private Bag 13302, Windhoek, or be delivered at Justitia Building, Independence Avenue, Second Floor, Room 219, Windhoek, not later than **12h00** on the ninth working day before the date of publication of this *Government Gazette* in which the advertisement is to be inserted.

3. Advertisements are published in this *Government Gazette* for the benefit of the public and must be furnished in English by the advertiser or his agent.

4. Only legal advertisements shall be accepted for publication in the *Government Gazette* (Estates) and are subject to the approval of the Permanent Secretary, Ministry of Justice, who may refuse the acceptance of further publication of any advertisement.

5. The Ministry of Justice reserves the right to edit and revise copy and to delete there from any superfluous detail.

6. Advertisements must as far as possible be typewritten. The manuscript of advertisements must be written on one side of the paper only and all proper nouns plainly inscribed. ORDER

Having heard Ms K. Kazondunge Counsel for the Applicant and having read the Notice of Motion, Affidavits and annexures thereto;

IT IS HEREBY ORDERED THAT:

1. A rule nisi is hereby issued calling upon CBM Trading Enterprises CC ("CBM") and Desmond Romeo Rudath ("Mr Rudath") to show cause, if any, on **27 March 2015** at **10h00** why an order in the following terms should not be made final:

1.1. That a preservation of property order, as contemplated by section 51 of the Prevention of Organised Crime Act, Act No. 29 of 2004 ("POCA") is granted in respect of the positive balance in Bank Windhoek account number CHK8003501889 ("Roma's Cheque Account"), the positive balance in Bank Windhoek account number NDP 3001017715 ("Roma's Savings account"), the positive balance in First National Bank account number 62248835459 held in the name of CBM Trading Enterprises CC ("CBM's FNB account") herein collectively referred to as ("the properties").

1.2. That in terms of section 51 of POCA all persons with knowledge of this order, other than as required and permitted by this order, are prohibited from removing, and or taking possession of and / or control over, and / or dissipating, and I or encumbering and I or interfering with, and / or diminishing the value of, and I or attaching or selling in execution, and I or dealing in any other manner with any of 'the properties' to which this order relates.

1.3. That Warrant Officer Emilia Nambadi ("Warrant Nambadi") of the Commercial Crime Investigation Unit: Anti - Money laundering Sub Division in Windhoek or, in Warrant Nambadi's absence, Warrant Officer Green ("Warrant Green") of the Commercial Crime Investigation Unit: Anti - Money laundering Sub - Division in Windhoek, is appointed as Curator Bonis in terms of section 55 of POCA and is immediately authorized to:

1.3.1. Seize and or assume control over the properties;

1.3.2. Safeguard the property pending the finalization of the forfeiture proceedings under POCA;

1.3.3. If necessary to administer and preserve the property and to do all things necessary for that purpose, including keeping the properties in the bank account where it is currently kept subject to appropriate safeguards and I or deposit the property in the account in a separate interest bearing account.

1.4. The Applicant must effect service of the provisional preservation of property order with the rule nisi granted on 4 March 2015 and the application on:

1.4.1. Desmond Romeo Rudath; 1.4.2. CBM Trading Enterprises CC; 1.4.3. Carlos Venane Mupaine; 1.4.4. Martha Berthina Mupaine.

1.5. The Applicant must effect service of the final preservation of property order and the application on:

- 1.5.1. Desmond Romeo Rudath; 1.5.2. CBM Trading Enterprises CC; 1.5.3. Carlos Venaune Mupaine; 1.5.4. Martha Berthina Mupaine.

1.6. In terms of section 52 (1) (b) cause notice of this order, in the form set out in Annexure B hereto, to be published in the Government Gazette as soon as practicable after the final preservation of property order is granted.

1.7. Any person who has an interest in the properties and who intends opposing the application for an order forfeiting the properties to the State or applying for an order excluding his or her interest from a forfeiture order in respect of the property, must enter an appearance giving notice of his or her intention in terms of section 52 (3) of POCA.

1.8. Such notice must be delivered to the Applicant:

- 1.8.1. in the case of any person specifically identified for service in the terms of this order, within 21 calendar days of service; and

2. Paragraphs 1.1. to 1.3 supra are to operate as an interim order with immediate effect pending the return date of the rule nisi.
