PROCEDURE FOR ADVERTISING IN THE GOVERNMENT GAZETTE OF THE REPUBLIC OF NAMIBIA

1. The *Government Gazette* (Estates) containing advertisements, is published on every Friday. If a Friday falls on a Public Holiday, this *Government Gazette* is published on the preceding Thursday.

2. Advertisements for publication in the *Government Gazette* (Estates) must be addressed to the Government Gazette office, Private Bag 13302, Windhoek, or be delivered at Justitia Building, Independence Avenue, Second Floor, Room 219, Windhoek, not later than **12h00** on the ninth working day before the date of publication of this *Government Gazette* in which the advertisement is to be inserted.

3. Advertisements are published in this *Government Gazette* for the benefit of the public and must be furnished in English by the advertiser or his agent.

4. Only legal advertisements shall be accepted for publication in the *Government Gazette* (Estates) and are subject to the approval of the Permanent Secretary, Ministry of Justice, who may refuse the acceptance of further publication of any advertisement.

ORDER

Having heard **Ms K. Kazondunge** Counsel for the Applicant and having read the Notice of Motion, affidavits and annexures thereto;

IT IS HEREBY ORDERED THAT:

- 1. A rule *nisi* is hereby issued calling upon **Jacob Kennedy** to show cause, if any, on **10 April 2015** at **10:00 am** why an order in the following terms should not be made final:
 - 1.1. That a preservation of property order, as contemplated by Section 51 of the Prevention of Organized Crime Act, Act No.29 of 2004 ("the Act") is granted in respect of a Volkswagen VW 250 –POLO 1.6 with registration number N100-289W ("the property").
 - 1.2. That in terms of section 51 of the Act all persons with knowledge of this order, other than as required and permitted by this order, are prohibited from removing, and or taking possession of and/or control over, and/or dissipating, and/or encumbering and/ or interfering with, and/or diminishing the value of, and/or attaching or selling in execution, and/or dealing in any other manner with the property to which this order relates.
 - 1.3. That Warrant Officer Emilia Nambadi ("Warrant Nambadi") of The Namibian Police Force ("NAM-POL"), Commercial Crime Investigation Unit: Anti Money Laundering Sub Division in Windhoek or, in Warrant Nambadi's absence, Warrant Officer Johan Nico Green ("Warrant Green") of NAM-POL Commercial Crime Investigation Unit: Anti Money Laundering Sub Division in Windhoek, is appointed as *Curator Bonis* in terms of section 55 of the Act and is immediately authorized to:
 - 1.3.1. Seize and or assume control over the property;
 - 1.3.2. Safeguard the property pending the finalization of the forfeiture proceedings under the Act;

- 1.3.3. If necessary to administer and preserve the property and to do all things necessary for that purpose.
- 1.4. No person is allowed to make public any information which may reveal the identity of the Complainant or any witnesses in the criminal case investigated under Katutura CR91/01/2015.
- 1.5. All information pertaining to the Complainant in the criminal case investigated under Katutura CR91/01/2015 must be deleted from the record of the proceedings prior to the application being served on any identified interested party to be served with this application.
- 1.6. The Applicant must effect service of the provisional preservation of property order with the rule *nisi* granted on **13 March 2015** and the application on Jacob Kennedy.
- 1.7. The Applicant must effect service of the final preservation of property order and the application on:
 - 1.7.1. Jacob Kennedy and
 - 1.7.2. First National Bank
- 1.8. In terms of section 52 (1) (b) of the Act, the Applicant must cause notice of this order, in the form set out in Annexure B hereto, to be published in the Government Gazette as soon as practicable after the final preservation of property order is granted.
- 1.9. Any person who has an interest in the property and who intends opposing the application for an order forfeiting the property to the State or applying for an order excluding his or her interest from a forfeiture order in respect of the property, must enter an appearance giving notice of his or her intention in terms of section 52 (3) of the Act.
- 1.10. Such notice must be delivered to the Applicant:
 - 1.10.1. in the case of any person specifically identified for service in terms of this order, within 21 calendar days of service; and
 - 1.10.2. in the case of any other person, 21 calendar days after the date when a notice of the order was published in the Government Gazette.
- 1.11.A notice in terms of section 52 of the Act must contain full particulars of the chosen address for the delivery of documents concerning further proceedings in this matter and must be accompanied by an affidavit setting out:
 - 1.11.1. the full particulars of the identity of the person giving the notice;
 - 1.11.2. the nature and extent of his or her interest in the property concerned;
 - 1.11.3. whether he or she intends opposing the making of the forfeiture order, or whether

he or she intends applying for an order excluding his or her interest in the property from the operation of the order;

- 1.11.4. whether he or she admits or denies that the property concerned is an instrumentality of crime and the basis for such defence;
- 1.11.5. if he or she intends applying for the exclusion of his or her interests from the operation of the forfeiture order, the basis for such an application.

Having heard **Ms. K. Kazondunge** Counsel for the Applicant and **Mr. B. Isaacks** Counsel for the Respondent and having read the documents filed of record:

IT IS HEREBY ORDERED THAT:

- 1. The *rule nisi* granted on **13 March 2015** is hereby confirmed;
- 2. The preservation of property order is varied by agreement between the parties as follows:
- 2.1. By the insertion of paragraph 1.3.4 as follows:

'1.3.4: 'Subject to the provision of paragraph 1.2, Jaco Marius Kennedy ("the Respondent") is allowed to take possession of the property subject to the following conditions:

- 1.3.4.1 The Respondent must, before he takes possession, comprehensively insure the property for the value of N\$112 000. A copy of the insurance must be submitted to the Applicant within two weeks of this order. The Respondent must comply with any conditions set out in his insurance policy.
- 1.3.4.2 Only the Respondent and his wife are allowed to use the property;

Applicant

Respondent

- 1.3.4.3 The Respondent must bring the property to the Windhoek Police Station every second Friday at 14:00 for inspection by Warrant Nambadi, who will file a report with the Applicant after inspection of the property.
- 1.3.4.4 Any damage to the property must be reported to Warrant Nambadi within 48 hours after the damage to the property is detected.
- 1.3.4.5 Should the report filed by Warrant Nambadi reveal substantial damage to the property and the damage was not reported to Warrant Namdadi, Warrant Nambadi is authorized to immediately seize the property from the Respondent and the Respondent shall be liable for the damages on the property.
- 1.3.4.6 The Insurance by the Respondent referred to in 1.3.4.1 above should not affect his contractual obligations to First National Bank and the Respondent must fulfill his contractual obligations to First National Bank of Namibia, Wes Bank Branch, First City Centre, Levinson Arcade, Windhoek in respect of the property.
- 1.3.4.7 The property is not allowed to leave the jurisdiction of this Honourable Court.
- 1.3.4.8 Should the property be damaged beyond economic repairs and subsequently written off by the insurance company due to the negligence of the Respondent or a 3rd party or due to any other reason the payment made by the insurance company of the Respondent or 3rd party will represent the property and shall be kept in the trust account of the Respondent's legal practitioner up until the finalization of the forfeiture proceedings;
- 1.3.4.9 Should the Respondent or any other person who has knowledge of the preservation order as amended, intentionally refuse or fail to comply with this order, that person will be committing an offence as contemplated in section 89(2) of the Act and the property will be seized by Warrant Nambadi.'

The High Court has made a preservation of property order over property pursuant to section 51 of the Prevention of Organised Crime Act 2004. It may also contain other orders that the court considers appropriate.

You have received this notice because the Prosecutor – General considers that you might have an interest in the properties which are the subject of the preservation order.

The preservation of property order has been made for the purpose of securing property in order to satisfy any forfeiture order that might be pursuant to Part 3 of Chapter 6 of the Prevention of Organised Crime Act 2004.

WARNING

The preservation of property order prohibits any person from dealing, in any manner, with the properties to which the order relates. A person who intentionally refuses or fails to comply with a court order made under this Act commits an offence punishable by a fine not exceeding N\$ 300,000 or to imprisonment for a period not exceeding 15 years.

Notice in terms of section 52 of the Prevention of Organised Crime Act 29 of 2004 (POCA)

This notice is addressed to all persons who have an interest the Volkswagen VW 250-POLO 1.6 with registration number N100-289W ("the property");

Take notice that:

- The Prosecutor General has obtained a preservation of property order (the order), a copy of which is attached to this notice, in terms of section 51 of the POCA in respect of the property;
- 2. If you have an interest in the properties, you should understand that it is now at risk. You are advised to obtain legal advice on whether your interest can be protected and, if so, on how to protect it;
- 3. You are notified that the Prosecutor General will, within 120 days of publication of this notice, apply to the High Court under section 59 of the POCA for an order declaring the properties forfeit to the state. The order will remain in force until the application for a forfeiture order is finalised, and until any forfeiture order that has been made is satisfied;
- 4. If you intend to oppose the application for a forfeiture order, or you intend to apply for an order excluding your interest from a forfeiture order in respect of the property, you must enter an appearance in terms of the order. The requirements for such an appearance are set out in the order and are also dealt with in sections 52 (3), (4) and (5) of the POCA. An appearance must comply with these requirements;

- If you enter an appearance in terms of the order you will be entitled to be given 21 days notice of the application by the applicant for a forfeiture order in respect of the property;

If you fail to enter an appearance in terms of the order or to comply with the above requirements, you will not be given notice of the application for a forfeiture order and you will not be entitled to appear at the hearing of the application. In such a case, the court may grant a default order forfeiting the property to the state under section 64 of the POCA;
