PROCEDURE FOR ADVERTISING IN THE GOVERNMENT GAZETTE OF THE REPUBLIC OF NAMIBIA

1. The *Government Gazette* (Estates) containing advertisements, is published on every Friday. If a Friday falls on a Public Holiday, this *Government Gazette* is published on the preceding Thursday.

2. Advertisements for publication in the *Government Gazette* (Estates) must be addressed to the Government Gazette office, Private Bag 13302, Windhoek, or be delivered at Justitia Building, Independence Avenue, Second Floor, Room 219, Windhoek, not later than **12h00** on the ninth working day before the date of publication of this *Government Gazette* in which the advertisement is to be inserted.

3. Advertisements are published in this *Government Gazette* for the benefit of the public and must be furnished in English by the advertiser or his agent.

4. Only legal advertisements shall be accepted for publication in the *Government Gazette* (Estates) and are subject to the approval of the Permanent Secretary, Ministry of Justice, who may refuse the acceptance of further publication of any advertisement.

5. The Ministry of Justice reserves the right to edit and revise copy and to delete there from any superfluous detail.

IT IS HEREBY ORDERED THAT:

1. The properties which are presently subject to a preservation of property order granted by this Honourable Court under above case number on 11 April 2012, namely: The positive balance in Sanlam Namibian Unit Trust Windhoek account number 62035560342 with investment number 65265442; the positive balance in FNB Oranjemund account number 62048276746 held in the name of Gerson Uuyuni; the positive balance in FNB Oranjemund account number 74242731111 held in the name of Gerson Uuyuni; Toyota Hilux Bakkie with registration number N2PAONA and a BMW with registration number N1903W hereinafter collectively referred to as ("the properties") be forfeited to the State in terms of section 61 of the Prevention of Organised Crime Act 29 of 2004 ("POCA").
2. In the interim, the aforesaid properties are to remain under the control and supervision of Inspector Rector Sandema ("Insp Sandema") and in Insp Sandema's absence any other authorized member of the Commercial Crime Investigation Unit: Anti - Money laundering Sub - Division in Windhoek, subject to the further orders set out below.
3. Insp Sandema and in his absence any other authorized member of the Commercial Crime Investigation Unit: Anti - Money laundering Sub - Division in Windhoek is directed to:
 - 3.1 Pay the positive balance in Sanlam Namibian Unit Trust Windhoek account number 62035560342 with investment number 65265442; the positive balance in FNB Oranjemund account number 62048276746 held in the name of Gerson Uuyuni; the positive balance in FNB Oranjemund account number 74242731111 held in the name of Gerson Uuyuni into the Asset Recovery Account: Ministry of Justice- POCA, Standard Bank Account Number 589245309 Branch Code 08237200.
 - 3.2 Sell the Toyota Hilux Bakkie with registration number N2PAONA and a BMW with registration number N1903W at a public auction for a value not less than the market value of the vehicles and to deposit the proceeds of the sale into the Asset Recovery Account.
4. Any person whose interest in the properties concerned is affected by the forfeiture order, may within 20 days after he or she has acquired knowledge of such order, set the matter down for variation or rescission by the Court.

ORDER

Having heard **Mrs K. Kazondunge** Counsel for the Applicant and having read the Notice of Motion, Affidavits and annexures thereto;

IT IS HEREBY ORDERED THAT:

1. The matter is heard as one of urgency and the Applicant's non compliance with the forms and service for by the Rules are condoned.
2. The prescribed manner as set out in the regulations to the Prevention of Organised Crime Act 29 of 2004 ("POCA") as well as any prescribed manner in terms of POCA is dispensed with.
3. A preservation of property order as contemplated by section 51 of POCA is granted in respect of the positive balance in Bank Windhoek account number: 3000841878, Swakopmund branch held in the name of Kronelia Ndilimeke Atanasius and the positive balance in Standard Bank account number: 143215132, Swakopmund branch held in the name of Kronelia Ndilimeke Atanasius ("the properties").
4. That in terms of section 51 of POCA all persons with knowledge of this order, other than as required and permitted by this order, are prohibited from removing, and or taking possession of and / or control over, and / or dissipating, and / or encumbering and / or interfering with, and / or diminishing the value of, and / or attaching or selling

- in execution, and / or dealing in any other manner with the property to which this order relates.
5. That Warrant Officer Emilia Nambadi (“Warrant Nambadi”) of the Commercial Crime Investigation Unit: Anti - Money laundering Sub - Division in Windhoek or, in Warrant Nambadi’s absence, any other authorised member of the Commercial Crime Investigation Unit: Anti - Money laundering Sub - Division in Windhoek, is appointed as Curator Bonis in terms of section 55 of POCA and is immediately authorized to:
 - 5.1. Seize and or assume control over the properties;
 - 5.2. Safeguard the properties pending the finalization of the forfeiture proceedings under POCA;
 - 5.3. If necessary to administer and preserve the properties and to do all things necessary for that purpose, including keeping the properties in the bank account where it is currently kept subject to appropriate safeguards and / or deposit the properties in the account in a separate interest bearing account.
 6. The Applicant must affect service of the preservation of property order and the application on Kronelia Ndilimeke Atanasius.
 7. In terms of section 52 (1) (b) cause notice of this order, in the form set out in Annexure A and B hereto, to be published in the Government Gazette as soon as practicable after the preservation of property order is granted.
 8. Any person who has an interest in the properties and who intends opposing the application for an order forfeiting the properties to the State or applying for an order excluding his or her interest from a forfeiture order in respect of the properties, must enter an appearance giving notice of his or her intention in terms of section 52 (3) of POCA.
 9. Such notice must be delivered to the Applicant:
 - 9.1. in the case of any person specifically identified for service in the terms of this order, within 21 calendar days of service; and
 - 9.2. in the case of any other person, 21 calendar days after the date when a notice of the order was published in the Government Gazette.
 - 9.3. A notice in terms of section 52 of POCA must contain full particulars of the chosen address for the delivery of documents concerning further proceedings in this matter and must be accompanied by an affidavit setting out:
 - 9.4. the full particulars of the identity of the person giving the notice;
 - 9.5. the nature and extent of his or her interest in the properties concerned;
 - 9.6. whether he or she intends opposing the making of the forfeiture order, or whether he or she intends applying for an order excluding his or her interest in the properties from the operation of the order;
