PROHIBITION OF USE OF CERTAIN MARK AND WORDS: OTJINENE VILLAGE COUNCIL: MERCHANDISE MARKS ACT, 1941

Under section 15(1) of the Merchandise Marks Act, 1941 (Act No. 17 of 1941), I prohibit the use, of any person other than the Otjinene Village Council, of the -

- (a) mark shown below in connection with any trade, business, profession or occupation or in connection with a trade mark, mark or trade description applied to goods without the consent of the Village Council; and
- (b) words Otjinene, village, council, development, service and unity and devices of guinea fowl, ox-wagon and tortoise if they are used together with the mark shown below in connection with a trade mark, mark or trade description applied to goods.
