Having heard **Ms L.N. Angula**, on behalf of the applicant and having read the Notice of Motion, affidavits and annexures thereto and other documents filed of record:

### IT IS HEREBY ORDERED THAT:

- The property which is presently subject to a preservation
  of property order granted by this Honourable Court under the above case number on 17 June 2016, namely: a
  White Mazda, with license number N27521W and engine
  number AFANBDN01NR618239, registered in the name
  of Musiwa Norman Chikwekwete ("the property") be forfeited to the State in terms of section 61 of the Prevention
  of Organised Crime Act, 29 of 2004 ("POCA").
- 2. The property is to remain under the control and supervision of Sergeant Hendrick Shaakumeni ("Sgt Shaakumeni") and in his absence, the property shall be under the control and supervision of Warrant Officer Emilia Nambadi ("W/0 Nambadi") or any other authorized member of Nampol, subject to the further orders set out below.
- Sgt Shaakumeni and in his absence, W/O Nambadi or any other authorized member of Nampol is directed to:
  - 3.1 Deliver the White Mazda, with license number N27521W and engine number AFANBDN-01NR618239 to the Asset Recovery Fund to be dealt with in terms of section 76 of POCA.
- 4. Any person, whose interest concerned is affected by the forfeiture order, may within 20 days after he or she has acquired knowledge of such order, set the matter down for variation or rescission by the Court.
