In terms of section 23(3) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is hereby made known that the Minister has, under section 23(1)(e) of the said Ordinance, in the districts of Grootfontein and Tsumeb, amended the classification of main road 72 described in the Schedule and shown on sketch-map P2372 by the symbols A-B-C-D-E-F-G-H, to trunk road 15/2.

The said sketch-map shall at all times lie open to inspection at the office of the Roads Authority, Windhoek, during normal office hours.
