DECLARATION OF MARIENTAL EXTENSION 6 TO BE AN APPROVED TOWNSHIP: TOWNSHIPS AND DIVISION OF LAND ORDINANCE, 1963

In terms of section 13 of the Townships and Division of Land Ordinance, 1963 (Ordinance No. 11 of 1963), I -

- (a) declare the area situated on Portion No. 703, a portion of Portion C, of the Farm Koichas No. 89, Registration Division "R", Hardap Region and represented by the General Plan No. R110 (S.G. No. A803/2017), to be an approved township; and
- (b) set forth in the Schedule the conditions subject to which the application for permission to establish the township concerned has been granted.

SCHEDULE

1. Name of township

The township is called Mariental Extension 6.

2. Composition of township

The township comprises 258 erven numbered 1215 to 1472 and the remainder are streets as indicated on the General Plan No. R110 (S.G. No. A803/2017).

3. Reservation of erven

The following erven are reserved for the local authority:

- (a) Erf 1215 is reserved for cemetery purposes;
- (b) Erven 1461 to 1471 are reserved for public open spaces; and
- (c) Erf 1472 is reserved for street purposes.

4. Conditions of title

The following conditions must be registered in favour of the local authority against the title deeds of all erven, except the erven referred to in paragraph 3:

- (a) The erf must only be used or occupied for purposes which are in accordance with, and the use or occupation of the erf must at all times be subject to, the provisions of the Mariental Town Planning Scheme prepared and approved in terms of the Town Planning Ordinance, 1954 (Ordinance No.18 of 1954).
- (b) The building value of the main building, including the outbuildings to be erected on the erf must be at least four times the prevailing valuation of the erf.
