APPROVAL IN TERMS OF SECTION 6(5) OF THE NATIONAL SYMBOLS OF THE REPUBLIC OF NAMIBIA ACT, 2018

Under the power vested in me by section 6(5) of the National Symbols of the Republic of Namibia Act, 2018 (Act No. 17 of 2018), I approve the following logos, which incorporate partially or in full, the National Flag or Coat of Arms of Namibia, for use by the -

- (a) Financial Intelligence Centre, as set out in Schedule 1;
- (b) Office of the Judiciary in relation to E-Justice, as set out in Schedule 2; and
- (c) Namibia Training Authority, as set out in Schedule 3.

PART B MEANING OF THE LOGO OF THE FINANCIAL INTELLIGENCE CENTRE

- 1. The two large golden stars on each side of the blue circle around the Coat of Arms represent Vigilance and Integrity. These values are embodied by the Financial Intelligence Centre as the national centre for combatting money laundering, terrorist financing and proliferation financing.
- 2. The circle of golden stars around the Coat of Arms represents Unity of Purpose which guides the Financial Intelligence Centre's common goal of safeguarding the integrity of Namibia's financial system.

#### PART B DESCRIPTION OF THE LOGO OF EJUSTICE

The logo comprises of the acronym for the eJustice application, namely "eJ" in the colours, layout and design of the Namibian flag, followed by the name of the application "eJUSTICE" to the right and the country to which it belongs, namely "NAMIBIA", underneath the words eJUSTICE. Both the name of the application and the country are printed in black.

#### DESCRIPTION OF THE LOGO OF THE NAMIBIA TRAINING AUTHORITY

- 1. The logo is in the shape of the bright Namibian sun, which is a key element of the Namibian flag. The radiating sun signifies inclusivity, hope and equality, while capturing the important potential the technical and vocational training sector holds to support the country's journey into the future.
- 2. Typefaced in the middle, a workbench makes up the 'T' in the Namibia Training Authority abbreviation, NTA; denoting modernisation, innovation and hard work. The merged and recognisable graph-like font lines not only convey uniqueness, but a strong sense of growth and progression, as well.
