**DECLARATION OF UNDESIRABLE PRACTICE IN TERMS OF SECTION 4(9)  
OF THE MEDICAL AID FUNDS ACT, 1995**

1. Under section 4(9) of the Medical Aid Funds Act, 1995 (Act No. 23 of 1995) (“the Act”), I hereby declare the following practices by registered medical aid funds (“Funds”) as undesirable practices, which must be eliminated by the respective dates stipulated in paragraph 2 below:
  - a) granting discounts on contribution rates to individual members, group members and different sized group members;
  - b) loading of contribution rates of individual members, group members and different sized group members;
  - c) the calculation of an individual’s contribution rate based on the age of the oldest beneficiary and designating the said beneficiary as the principal member; and
  - d) determining any other form of contribution rate that ultimately results in a direct or indirect discount.
  
2. Given the potential impact of the contribution adjustment on Fund Members, this Declaration will be phased in over a period of three (3) years in respect of the current practices by Funds. The phased in approach applies as follows:
  - a) granting discounts on contribution rates to individual members, group members and different sized group members, must be eliminated by 31 December 2023;
  - b) loading of contribution rates of individual members, group members and different sized group members, must be eliminated by 31 December 2023;
  - c) the calculation of an individual’s contribution rate based on the age of the oldest beneficiary and designating the said beneficiary as the principal member, must be eliminated by 1 January 2021; and
  - d) determining any other form of contribution rate that ultimately results in a direct or indirect discount, must be eliminated by 31 December 2023.
  
3. Funds may not grant any new discounts to any Member from the date of the Declaration or at any time after the three year phase in period.

This Declaration, which is effective immediately, is applicable to all Funds. Any contravention of this Declaration will be dealt with in terms of section 39(1)(a)(ii) and section 45 the Act.

In terms of regulation 3 of the Regulations Relating to Nomination of Candidates and Election of Members of Council, published under Government Notice No. 358 of 20 November 2019, I -
