PROMULGATION OF ACT OF PARLIAMENT

The following Act which has been passed by the Parliament and signed by the President in terms of the Namibian Constitution is hereby published in terms of Article 56 of that Constitution.

No. 7 of 2020: Post and Telecommunications Companies Establishment Amendment Act, 2020.

ACT

To amend the Posts and Telecommunications Companies Establishment Act, 1992, so as to delete, substitute and insert certain definitions; to make the State the sole shareholder of the successor companies; to authorise the dissolution of the holding company; and to provide for incidental matters.

(Signed by the President on 23 July 2020)

BE IT ENACTED as passed by the Parliament, and assented to by the President, of the Republic of Namibia, as follows:

Amendment of section 1 of Act No. 17 of 1992

1. Section 1 of the Posts and Telecommunications Companies Establishment Act, 1992 (in this Act referred to as “the principal Act”) is amended by -

- (a) the insertion after the definition of “department” of the following definition:

““dissolved company” means the holding company to be dissolved under section 5A;”;

- (b) the deletion of the definition of “holding company”;

- (c) the substitution for the definition of “Minister” of the following definition:

““Minister” means the Minister responsible for information and communication technology;”; and

- (d) the insertion after the definition of “Postmaster-General” of the following definition:

““Public Enterprises Governance Act” means the Public Enterprises Governance Act, 2019 (Act No. 1 of 2019);”.

Amendment of section 2 of Act No. 17 of 1992

- 2.** Section 2 of the principal Act is amended -

- (a) by the substitution for subsection (1) of the following subsection:

“(1) There is hereby established [**three**] two corporate bodies namely -

- (a) a postal company to conduct a postal service and the supplementary services, and which shall be known as Namibia Post Limited; and
 - (b) a telecommunications company to conduct a telecommunications service, and which shall be known as Telecom Namibia Limited.]; **and**
 - (c) **a holding company which shall hold the shares in the postal company and the telecommunications company, and which shall be known as Namibia Post and Telecom Holdings Limited.]**”;
- (b) by the deletion of subsection (8);
- (c) by the substitution for paragraph (b) of subsection (9) of the following paragraph:
- “(b) shall have the power [, **subject to the approval of the holding company,**] to enter into performance contracts with the Minister for the performance of specified functions by the company and the rendering of services in connection therewith;”;
- (d) in subsection (10) -
- (i) by the substitution for paragraph (a) of the following paragraph:
- “(a) the postal company and the telecommunications company shall *inter alia* provide that -
- (i) the company shall have [**no**] not less than [**three**] five and [**nor**] not more than [**five**] seven directors;
 - [(ii) one of the directors shall be appointed as managing director;]**
 - (iii) the directors [, **with the exception of the managing director,**] shall fulfil a non-executive function;
 - (iv) no person, except the [**holding company**] State, shall, whether directly or indirectly, hold any shares in the company.];”]; and
- (ii) by the deletion of paragraph (b);
- (e) by the deletion of subsection (10A); and
- (f) by the substitution for subsection (13) of the following subsection:

“(13) The powers and duties of the State as a sole member and shareholder of the [holding company] successor companies shall be exercised and performed by the Minister or a person nominated by the Minister in writing from time to time.”.

Amendment of section 4 of Act No. 17 of 1992

3. Section 4 of the principal Act is amended by -
- (a) the substitution for subsections (1), (2) and (3) of the following subsections:
- “(1) On a date determined by the Minister by notice in the *Gazette* -
- (a) the postal enterprise shall[, **subject to subsection (4),**] be transferred to the postal company, from which date the postal company shall be entitled to conduct a postal service and the supplementary services, subject to the Posts and Telecommunications Act, 1992;
- (b) the telecommunications enterprise shall[, **subject to subsection (4),**] be transferred to the telecommunications company, from which date the telecommunications company shall be entitled to conduct a telecommunications service, subject to the Posts and Telecommunications Act, 1992.
- (2) For the purposes of subsection (1), any State land of which the postal enterprise and the telecommunications enterprise have the use immediately before the transfer date, shall on that date[, **but subject to subsection (4),**] pass to the postal company or the telecommunications company, as the case may be.
- (3) [**Subject to subsection (4), a**] Any servitude, other real right or lease existing immediately before the transfer date in favour of the State, the department or the Postmaster-General and which is exercised in favour of the postal enterprise or the telecommunications enterprise shall on the transfer date pass to the postal company or the telecommunications company, as the Minister shall determine.”;
- (c) the deletion of subsections (4) and (5);
- (d) the substitution for subsection (6) of the following subsection:
- “(6) The Registrar of Deeds shall on submission to him or her of a certificate by the Minister -
- (a) that State land or any servitude, other real right or lease has passed in terms of subsection (2), (3)[, (4)] or (5), free of charge, make such entries and endorsements as he or she may deem necessary in or on any relevant register, title deed or other document in his or her

office or laid before him or her in order to effect the transfer in the name of the company in question;

- (b) that a servitude exists over land which has passed in terms of subsection (2) **[, (4)]** or (5), make such entries and endorsements as he or she may deem necessary in or on any relevant register, title deed or other document in his or her office or laid before him or her in order to confirm the existence of the servitude in favour of any person over land which has so passed.”;

- (e) the substitutions for subsection (7) and (8) of the following subsections:

“(7) The value of the assets and liabilities of the enterprises transferred in terms of subsection (1) **[, including any assets or liabilities referred to in subsection (4),]** shall be determined by the Minister with the concurrence of the Minister responsible for finance and the Minister responsible for public enterprises, and the net asset value of those enterprises shall likewise be determined.”;

“(8) For the purposes of the Income Tax Act, 1981 (Act 24 of 1981), or any other law in terms of which a tax or levy may be imposed, it shall be deemed that expenses were actually incurred by a successor company in acquiring the assets transferred to it in terms of subsection (1) **[or (4)]** and that, notwithstanding the provisions of any other law, the expenses concerned, including the cost of the assets, are equal to the value determined in terms of subsection (7).”;

- (f) the substitution for subsection (14) of the following subsection:

“(14) No stamp duty, transfer duty or any other tax or levy shall be payable in respect of the transfer of the postal enterprise or the telecommunications enterprise in terms of this section, nor in respect of any transfer effected in pursuance of subsection **[(4) or] (5)**.”.

Insertion of section 4A in Act No. 17 of 1992

4. The principal Act is amended by the insertion after section 4 of the following section:

“Transfer of rights, liabilities and assets to successor companies

4A. (1) On the date of commencement of this Act, all the rights, assets, liabilities and obligations of the dissolved company shall vest in the State.

(2) On a date determined by the Minister in the *Gazette*, all immovable assets, rights or interests in any immovable assets of the dissolved company shall be transferred to the successor companies as set out in Schedule 2.

(3) The movable assets, rights or interests in the movable assets of the dissolved company shall be transferred to the successor companies on a date and in the manner determined by the Minister.

(4) Where, on or after the date determined in subsection (2) or (3), any steps are required to be taken in order to effect the transfer or delivery of any right, interest or asset of the dissolved company referred to in those subsections to the State or the successor companies such steps may be taken, subject to the directions of the Minister, by the board of the directors of the dissolved company.

(5) Any question as to whether any right, asset, liability or obligation of the dissolved company vests in the State as contemplated in subsection (1) or have been transferred to the successor companies as completed in subsection (2) or (3), shall be decided by the Minister.

(6) After the date determined under subsection (2) or (3), reference in any law or document to the dissolved company shall be construed as a reference to the State or the successor companies, respectively.

(7) The Registrar of Deeds shall, at the request of the Minister, effect the entries and endorsements which may be considered necessary in order to carry into effect the provisions of subsection (2) or (3).

(8) No transfer duty, stamp duty, office fees or other charges are payable in respect of any vesting in terms of subsection (1), (2) or (3) in respect of any entry or endorsement referred to in subsection (7).”.

Amendment of section 5 of Act No. 17 of 1992

5. Section 5 of the principal Act is amended by -
- (a) the substitution for subsections (1), (2) and (3) of the following subsections:
- “(1) The shares held by the dissolved company in the capital of the successor companies shall, on a date determined by the Minister, be transferred to the State, on such terms and conditions as the Minister, with the concurrence of the Minister responsible for finance and the Minister responsible for public enterprises, may determine.
- (2) The provisions of the Competition Act, 2003 (Act No. 2 of 2003), as well as sections 33(3), 35 and 97 of the Communications Act, 2009 (Act No. 8 of 2009) or any other law, do not apply to the transfer of the shares contemplated in subsection (1).
- (3) Section 4(8) applies, with the necessary changes, to the share transfer contemplated in subsection (1).”;
- [(1) As a consideration for the transfer contemplated in section 4(1) or (4), as the case may be -**
- (a) **the postal company and telecommunications company shall, in addition to the share referred to in section 2(8)(a), issue such**

**number of shares in those companies to the
holding company;**

- (b) the holding company shall, in addition to the share referred to in section 2(8)(b), issue such number of shares in that company to the State,**

as may, subject to the provisions of subsection (2), be determined by the Minister with the concurrence of the Minister of Finance.

(2) Should the nominal value plus any premium payable in respect of the number of shares determined in terms of subsection (1) by the Minister -

- (a) to be issued in the postal company or in the telecommunications company, be less than the net asset value of the enterprise concerned, an amount equal to that difference shall be credited to a loan account in favour of the holding company in the books of account of the postal company or the telecommunications company, as the case may be;**

- (b) to be issued in the holding company, be less than the aggregate of the net asset value of the postal enterprise and the telecommunications enterprise plus the net value of any assets transferred to the holding company by virtue of the provisions of section 4(4), an amount equal to that difference shall be credited to a loan account in favour of the State in the books of the holding company.**

(3) Any loan account created in terms of subsection (2) (a) or (b) shall bear interest at such rate and be repayable at such time or times and by such instalments as may be determined -

- (a) in the case of a loan account due to the holding company, by the directors of the holding company;**
- (b) in the case of a loan account due to the State, by the Minister.]**

(b) the deletion of subsections (4) and (5);

(c) the substitution for subsection (6) of the following subsection:

“(6) Any dividends received by the **[holding company]** State in respect of shares in the successor companies shall be paid into the State Revenue Fund.”;

(d) the substitution for subsection (9) of the following subsection:

“(9) The successor companies **[State shall not]** may not alienate **[any]** shares or rights to shares in the **[holding company]**

successor companies without the approval of the State. **[and the holding company shall not issue any shares in such company to any person other than the State].**”; and

- (e) the deletion of subsection (10).

Insertion of section 5A in Act No. 17 of 1992

6. The principal Act is amended by the insertion after section 5 of the following section:

“Dissolution of holding company

5A. (1) The holding company shall be dissolved on a date determined by the Minister by notice in the *Gazette* with the concurrence of the Minister responsible for public enterprises.

(2) The Minister may determine the manner of dissolution of the holding company and for that purpose may appoint any person he or she considers necessary to facilitate in the dissolution of the dissolved company.

(3) On receipt of a copy of the notice referred to in subsection (1) from the Minister, the Registrar of Companies shall deregister the holding company in terms of the relevant provisions of the Companies Act.

(4) All transitional matters and issues arising that are incidental to dissolving the holding company shall be dealt with by the Minister.”.

Insertion of section 6A in Act No. 17 of 1992

7. The principal Act is amended by the insertion after section 6 of the following section:

“Transfer of employees to successor companies

6A. (1) The dissolved company shall provide for the full and final settlement of all employee benefits that are due and payable at the date of dissolution of the dissolved company.

(2) The employees of the dissolved company who elect to be transferred to the successor companies shall be transferred to the successor companies on the date and in the manner determined by the Minister in consultation with the successor companies.

(3) The transfer of employees to the successor companies shall be subject to the terms and conditions agreed on between the successor companies and the employees.”.

Short title and commencement
