INVITATION FOR REPRESENTATIONS ON PROHIBITION OF USE OF CERTAIN MARK AND WORDS: ONGWEDIVA TOWN COUNCIL: MERCHANDISE MARKS ACT, 1941

In terms of section 13 of the Merchandise Act, 1941 (Act No. 17 of 1941), I invite -

- (a) persons interested in the request made, by the Ongwediva Town Council, for the prohibition under section 15(1) of that Act of the use by any person other than that Town Council or without the consent of that Town Council, of the -
- (i) mark set out in the Schedule; and
 - (ii) words "Freedom & Hard Work" used together with the device of a circular outline, a Namibian flag, two leaf branches and a leopard head, as illustrated in the mark contemplated in subparagraph (i),

in connection with any trade, business, profession or occupation or in connection with a trade mark, mark or trade description applied to goods; and

- (b) persons interested in the matter under paragraph (a) to submit, in writing, any representations which they wish to make on that matter to the Director of Commerce, Ministry of Industrialisation and Trade, Private Bag 13340, Windhoek, to reach the Director within 60 days from the date of publication of this notice in the *Gazette* or to the Director of Commerce, Ministry of Industrialisation and Trade, Second floor, Brendan Simbwaye Square, Block B, Corner of Dr. Kenneth D. Kaunda and Goethe Street, Windhoek, to reach the Director within 60 days from the date of publication of this notice in the *Gazette*.
