#### NOTICE OF INTENTION TO DECLARE COMMUNAL LAND AS ZAMBEZI STATE FOREST RESERVE: FOREST ACT, 2001

Under section 13(2) of the Forest Act, 2001 (Act No. 12 of 2001), I -

- (a) give notice that I intend to declare the communal land, in respect of which the geographical boundaries are identified and described in Schedule 1, to be the Zambezi State Forest Reserve;
- (b) invite any person who objects to the declaration referred to in paragraph (a) to, within 60 days of the publication of this notice in the *Gazette*, make written representations on the proposed declaration and management of the state forest reserve to the Director of Forestry, Ministry of Environment, Forestry and Tourism and the written representation must be submitted at -
  - (i) the Directorate of Forestry office, Ministry of Environment, Forestry and Tourism, Mpacha Road, Katima Mulilo; or
  - (ii) Room No. 305, Government Office Park, Luther Street, Windhoek,

alternatively, the written representations must be submitted via registered mail for the attention of the Director of Forestry, Ministry of Environment, Forestry and Tourism, Private Bag 13306, Windhoek, to reach the Director within the 60 days, and the objections must be made on the Form set out in Schedule 2;

- (c) give notice that if objections to the proposed declaration are not received by the Director within 60 days as contemplated in paragraph (b), I will proceed to declare the communal land referred to in paragraph (a) as the Zambezi State Forest Reserve; and
- (d) give notice that the management plan for the proposed state forest reserve as well as details of how the revenue to be derived from the state forest reserved will be disposed of, can be obtained at the offices referred to in paragraph (b).

### **SCHEDULE 1**

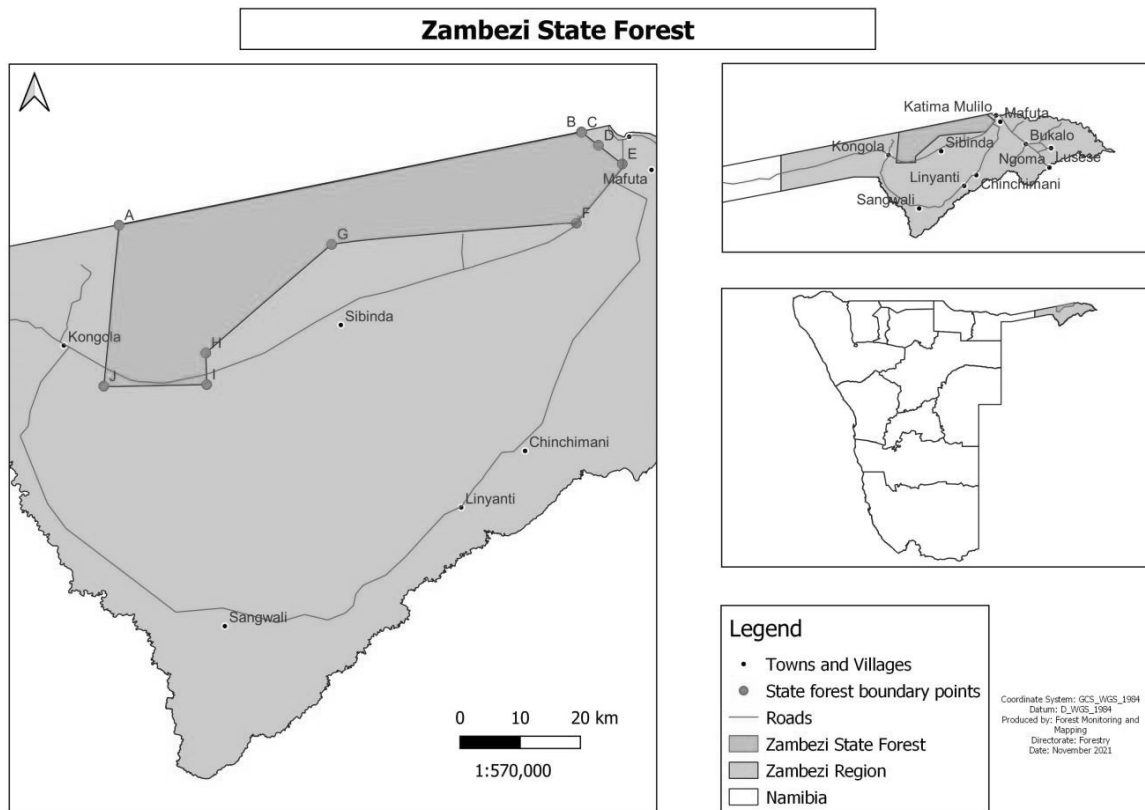
#### **BOUNDARY DESCRIPTION OF COMMUNAL LAND TO BE DECLARED AS ZAMBEZI STATE FOREST RESERVE: ZAMBEZI REGION**

Zambezi is a state forest reserve in the Kongola constituency, Zambezi region forming a part of its boundary with Zambia Namibia border in the northern direction. Beginning at Point A at the north-east corner point of the Kwando Conservancy lying on the international boundary of Namibia and Zambia, the boundary follows the international boundary in an easterly direction until Point B where it intersects with a north-westerly extension of the Katima Mulilo Local Authority area's western boundary. Than from Point B the boundary follows that extension line in a south-easterly direction for about 600 meters to Point C, the north-western boundary beacon with the designation XXX of Farm Wenela No. 2029, Survey Diagram A553/2007 Katima Mulilo Local Authority area. Than from Point C the boundary follows south-easterly along the Katima Mulilo Local Authority area's western boundary to Point D, the south-western beacon with the designation 476 of Farm Wenela No. 2029, Survey Diagram A553/2007 Katima Mulilo Local Authority area. Than from Point D the boundary follows the western boundary of the Katima Mulilo Townlands No. 1328 until it intersects the north-western edge of the B8 main road. Than from Point E the boundary follows the northern edge of the B8 in a south-westerly direction until Point F, a turnoff to the Mpacha Military Base which runs westerly along the northern side of the airport. Than from Point F the boundary follows that track westerly to Point G where it turns in south-westerly direction. Than from Point G the boundary follows that cutline in a south-westerly direction to Point H where it intersects the Nukwa cutline at the north-west corner of the Masida Community Forest. Than from Point H the boundary follows the cutline in a southerly direction to Point I, the north-east corner of the Lubuta Community Forest. Than from Point I the boundary follows westerly along the existing cutline forming the northern boundary of the Lubuta Community Forest to Point J where it meets a north-south cutline known as Masheke Ziba. Than from Point J the boundary follows that cutline which forms the eastern boundary of the Kwando Conservancy northerly back to the beginning Point A.
