#### MINISTRY OF INDUSTRIALISATION AND TRADE

No. 266

PROHIBITION ON IMPORTATION OF CERTAIN MOTOR VEHICLES INTO NAMIBIA: IMPORT AND EXPORT CONTROL ACT, 1994

In terms of section 2(1)(b) of the Import and Export Control Act, 1994 (Act No. 30 of 1994), I -

- (a) prohibit the importation into Namibia of second-hand motor vehicles older than 12 years, for categories of motor vehicles referred to in Annexure A to this notice, from outside the common customs area defined in section 1 of the Customs and Excise Act, 1998 (Act No. 20 of 1998);
- (b) prohibit the importation into Namibia of second-hand motor vehicles older than 12 years, for categories of motor vehicles referred to in Annexure A to this notice, from outside the common customs area defined in section 1 of the Customs and Excise Act, 1998 (Act No. 20 of 1998), and registered in the common customs area for less than two years prior to importation into Namibia;
- (c) exempt the categories of motor vehicles referred to in Annexure B to this notice from the provisions of paragraph (a) and (b) of this notice;

- (d) designate the port of Walvis Bay to be the port of entry for the importation of all second-hand motor vehicles from outside the common customs area defined in section 1 of the Customs and Excise Act, 1998 (Act No. 20 of 1998); and
- (e) repeal Government Notice Nos. 257 of 16 November 2004 and 252 of 23 September 2013.
