In terms of subsection (5) of section 96 of the Basic Education Act, 2020 (Act No. 3 of 2020), I invite the following ministries, institutions, associations or organisations to nominate not less than two and not more than four persons for the purpose of selection for appointment in terms of subsection (4) of that section as members of the Regional Education Forum –

- (a) unions of teachers;
- (b) the Ministry responsible for administering child welfare;
- (c) the Ministry responsible for administering health;
- (d) each regional council;
- (e) local authority councils in each region;

- (f) school boards in each region;
- (g) the Namibia Chamber of Commerce and Industry in each region;
- (h) the Namibian NGO Forum in each region;
- (i) Namibia National Students Organisation in each region;
- (j) learner's representative councils and prefects in each region;
- (k) Private school in the region nominated by their governing bodies in each region;
- (l) Representative of faith-based organisations nominated by the Council of Churches in Namibia in each region;
- (m) the Council of Traditional Leaders established by section 2 of the Council of Traditional Leaders Act, 1997 (Act No. 13 of 1997);
- (n) the Teaching Service; and
- (o) the National Disability Council established by the National Disability Council Act, 2004 (Act No. 26 of 2004).

In terms of subsection (4) of section 94 of the Basic Education Act, 2020 (Act No. 3 of 2020), I invite the following bodies to nominate not less than two and not more than four persons for the purpose of selection for appointment in terms of subsection (3) of that section as members of the National Advisory Council on Education –

- (a) institutions of higher education;
- (b) public enterprises;
- (c) each regional education forum;
- (d) non-governmental organisations;
- (e) national employers' organisations;

- (f) recognised associations;
- (g) unions of teachers;
- (h) representative bodies of learners and students;
- (i) representative bodies of churches;
- (j) private schools;
- (k) the Council of Traditional Leaders established by section 2 of the Council of Traditional Leaders Act, 1997 (Act No. 13 of 1997); and
- (l) a national organisation for persons with disabilities.
