AMENDMENT OF GENERAL NOTICE NO. 70 OF 30 MARCH 2007: IMPOSITION OF ROAD USER CHARGES: ROAD FUND ADMINISTRATION ACT, 1999

Under section 18(1)(a) and (b) of the Road Fund Administration Act, 1999 (Act No. 18 of 1999), the Road Fund Administration, after consultation with the Minister of Finance, amends, with effect from 1 May 2024, General Notice No. 70 of 30 March 2007 as amended by General Notice Nos. 29 of 9 March 2009, 68 of 8 March 2010, 61 of 30 March 2011, 117 of 11 May 2015, 168 of 6 June 2016, 116 of 25 April 2017, 171 of 30 April 2018, 90 of 23 April 2019, 243 of 26 June 2020, 175 of 7 May 2021 and 191 of 28 April 2023 as set out in the Schedule.
