DECENTRALISATION OF CERTAIN FUNCTIONS OF MINISTRY OF SPORT, YOUTH AND NATIONAL SERVICE TO REGIONAL COUNCILS: DECENTRALISATION ENABLING ACT, 2000

Under section 2 of the Decentralisation Enabling Act, 2000 (Act No. 33 of 2000), after consultation with the Ministry of Sport, Youth and National Service and in consultation with Cabinet, by way of delegation –

- (a) I decentralise the functions as defined in Column 2 of the Schedule from the line Ministry as identified in Column 1 of the Schedule to the regional councils as identified in Column 3 of the Schedule; and
- (b) the decentralisation by delegation of the functions of the line ministry to the regional councils as indicated in the Schedule is –
 - (i) made in respect of the entire area of such regional council;
 - (ii) not subject to any terms or conditions; and

(iii) effective from date of publication of this notice in the *Gazette*.
