## NOTICE IN TERMS OF SECTION 48(3)(A) OF THE SHORT-TERM INSURANCE ACT

#### WESTERN NATIONAL INSURANCE COMPANY LIMITED (Registration No. 2004/0069) SANTAM NAMIBIA LIMITED (Registration No. 1989/454)

Notice is hereby given in terms of section 48(3)(a) of the Short-Term Insurance Act, 1998 (Act No. 4 of 1998) (hereinafter referred to as "the Act") that it is the intention of Western National Insurance Company Limited (hereinafter referred to as "WNIC") and Santam Namibia Limited (hereinafter referred to as "Santam") to transfer the entire in-force insurance book of WNIC to Santam.

#### The Nature of the Transaction:

In 2024, WNIC and Santam entered into an agreement whereby WNIC will transfer its in-force insurance book to Santam. This strategic transaction allows WNIC to exit the short-term insurance market in Namibia and shift its focus to other business activities, while Santam will integrate these policies into its portfolio, ensuring continuity and maintaining service standards for all policyholders.

#### Abstract of the Terms and Conditions of the Transaction:

Santam will acquire WNIC's in-force insurance book, including all related insurance assets and liabilities, for a total cash consideration that will be adjusted for the initial solvency capital.

The transfer encompasses only the insurance business; no other liabilities of WNIC will be assumed by Santam.

Upon completion, WNIC's ten permanent operational staff members will be transferred to Santam, ensuring continuity of service and expertise.

Following the transaction, all policies originally issued by WNIC will be managed by Santam and recognised as Santam's policies.

The effective date of the transfer will be the first business day of the month following the fulfilment of all conditions precedent, including the High Court's approval of the transaction, which shall be the 3 March 2025.

The transaction is contingent upon the sanctioning by the High Court of Namibia, ensuring all statutory and regulatory requirements are met.

#### **High Court Application:**

WNIC and Santam intend to apply to the High Court of Namibia in Windhoek for an order sanctioning the Transfer. The application is scheduled for Friday, 21 February 2025, at 10h00 am, or as soon thereafter as the matter may be heard.

If the High Court sanctions the Transfer, Santam will assume full responsibility for all obligations related to the insurance business transferred from WNIC. Following this, the Registrar of Short-Term Insurance may proceed to cancel WNIC's registration as a short-term insurer in terms of section 17(15) of the Short-Term Insurance Act.

#### **Right to be Heard**

In terms of section 48(5) of the Short-Term Insurance Act, the Registrar of Short-Term Insurance, along with any policyholder, shareholder, creditor, or other person affected or likely to be affected by the Transfer, is entitled to be heard at the High Court hearing mentioned above. Any affected party may also file an application with the High Court in Windhoek regarding any aspect of the Transfer.

#### **Transaction Document Inspection:**

The documents related to the Transfer, including the Sale Agreement, an Abstract of the Terms, a Statement outlining the nature of the transaction, an Extract of WNIC's Annual Financial Statements, and an Independent Actuarial Report on the Transfer, will be available for inspection by policyholders, creditors, and shareholders of WNIC and Santam.

#### A *Rule Nisi* is hereby issued calling upon the Respondent(s) to show cause, if any to this Honourable Court, on or before the 19 April 2024 at 10h00, why an order should not be made in the following terms:

- A provisional preservation of property order as contemplated in section 51 of POCA is granted in respect of: The amount of N\$98 277.26 and all interest accrued thereon, in the Standard Bank account number 247267031 held in the name of Albert Haraseb, herein referred to as the "property".
- 2. In terms of section 51 of POCA all persons with knowledge of this order, other than as required and permitted by this order, are prohibited from removing, and or taking possession of and / or control over, and / or dissipating, and / or encumbering and / or interfering with, and / or diminishing the value of, and / or attaching or selling in execution, and / or dealing in any other manner with the property to which this order relates.
- 3. Inspector Johan Green ("Insp. Green") of the Anti-Money Laundering and Combating of Financing and Terrorism: Asset Recovery Sub-Division or, Insp. Green's absence, any authorised member of the the Anti-Money Laundering and Combating of Financing and Terrorism: Asset Recovery Sub-Division in Windhoek is appointed to take care of the property in terms of section 93 of POCA and is immediately authorized to:
  - 3.1. Seize and or assume control over the property;
  - 3.2. Safeguard the property pending the finalization of the forfeiture proceedings under POCA;
  - 3.3. If necessary to administer and preserve the property and to do all things necessary for that purpose, including keeping the positive balance in the bank account where it is currently kept subject to appropriate safeguards and / or deposit the positive balance in the account in a separate interest-bearing account.

- The provisional preservation of property order is granted with a rule nisi returnable on 22 March 2024 at 10h00 calling on Albert Haraseb or any person affected by the order to show cause why the preservation order should not be made final.
- 5. This order together with the preservation of property application must be served on Albert Haraseb.
- 6. Once the preservation of property is confirmed prayers 7-12 will come into effect.
  - The applicant must:
    - 7.1. Effect service of the preservation of property order and the application on Albert Haraseb.
    - 7.2. In terms of section 52(1)(b) cause notice of this order, in the form set out in Annexure A and Annexure B hereto, to be published in the *Gazette* as soon as practicable after the final preservation of property order is granted.
  - Any person who has an interest in the property and who intends opposing the application for an order forfeiting the property to the State or applying for an order excluding his or her interest from a forfeiture order in respect of the property, must enter an appearance giving notice of his or her intention in terms of section 52(3) of POCA.
- 9. Such notice must be delivered to the applicant at the applicant's appointed address at the Office of the Prosecutor-General, JP Karuaihe Street, Corporate House, Ground Floor, Windhoek:
  - 9.1. In the case of any person specifically identified for service in terms of this order, within 21 calendar days of service; and
  - 9.2. In the case of any other person, 21 calendar days after the date when a notice of the order was published in the *Gazette*.
- A notice in terms of section 52 of POCA must contain full particulars of the chosen address for the delivery of documents concerning further proceedings in this matter and must be accompanied by an affidavit setting out:
  - 10.1. The full particulars of the identity of the person giving the notice;
  - 10.2. The nature and extent of his or her interest in the property concerned;
  - 10.3. Whether he or she intends opposing the making of the forfeiture order, or whether he or she intends applying for an order excluding his or her interest in that property from the operation of the order;
  - 10.4. Whether he or she admits or denies that the property concerned are the proceeds of unlawful activities and the basis for such defence; and

- - 10.5. If he or she intends applying for the exclusion of his or her interests from the operation of the forfeiture order, the basis for such an application.
- 11. Any person, with an interest in the property, may, on good cause shown:
  - 11.1. In terms of section 57 of POCA apply to Court for payment from the property of reasonable living expenses and reasonable legal expenses on conditions set out in section 57 of POCA;
  - 11.2. In terms of section 58 of POCA, apply for the variation or recession of the preservation order on the conditions set out in section 58 of POCA.
- 12. Any affected person may make application on good cause shown to anticipate the return date for the purpose of discharging or varying the provisional order on not less than 24 hours' notice of such application to the applicant.
- Orders set in paragrphs 1- 6 of this Court Order will come into opereation with immediate effect.
- 14. The case is postponed to 19 April 2024 at 10h00 for the Return Date Hearing.
