#### Definitions

1. In these regulations "the Regulations" means the Regulations under the Immigration Control Act, 1993 published under Government Notice No. 134 of 29 July 1994, as amended by Government Notices No. 82 of 15 April 2008, No. 133 of 1 July 2010, No. 145 of 8 September 2014, No. 138 of 13 July 2018, No. 8 of 21 January 2020, No. 153 of 19 July 2021 and No. 327 of 29 September 2023.

## Addition of regulation 30 to Regulations

2. The Regulations are amended by the addition after regulation 29 of the following regulation:

### "Certificate of domicile

An application for obtaining proof of domicile for the purposes of section 30. (1) 22(1)(c) of the Act shall be in the form of Annexure "AG" and shall be lodged with the Chief of Immigration.

A certificate of domicile shall be issued in the form of Annexure "AH.". (2)
