#### Act No. 2, 2025

#### **APPROPRIATION ACT, 2025**

#### **ACT**

To appropriate amounts of money to meet the financial requirements of the State during the financial year ending 31 March 2026.

(Signed by the President on 4 June 2025)

**BE IT ENACTED** as passed by the Parliament, and assented to by the President, of the Republic of Namibia, as follows:

#### Appropriation of amounts of money for financial requirements of State

1. Subject to the State Finance Act, 1991 (Act No. 31 of 1991), the amounts of money shown in the Schedule are appropriated for the financial requirements of the State during the financial year ending 31 March 2026 as a charge to the State Revenue Fund.

#### **Short title**

**2.** This Act is called the Appropriation Act, 2025.
