5. Detailed reasons why such alteration, modification or amendment is sought:

- 5.1 The applicant is associated with the Wilderness Safari group of companies which operates tourist lodges in Namibia, Botswana, Zimbabwe, South Africa and Malawi.
- 5.2 The Wilderness Safari Group of companies accommodate in excess of 50 000 mainly foreign tourists in their lodges in Southern Africa per annum
- 5.3 Since the grant of the license in 1997 the applicant activity marketed the idea of visiting more than one lodge by air transfer on a single visit to Namibia and was successful to the extent that an exponential growth for air transfer between lodges and other places of interest in Namibia is being experienced.
- 5.4 For these reasons the applicant previously expanded its capacity fleet of aircraft substantially to meet the demand created in the Wilderness Safari Group of companies.

- 5.5 Such alterations were duty applied for and grated.
- 5.6 Current economic realities make it unfeasible and/or uneconomic to operate come of the previous fleet and applicant has made the decision to discontinue operation of these aircraft for purpose of its non-scheduled license.
- 5.7 Applicant has been advised that it should apply for an amendment of its License together with renewal thereof to correctly reflect the Aircraft it operates at this stage.
