INCREMENT OF HOUSING ALLOWANCES AND CAR ALLOWANCES OF MAGISTRATES: MAGISTRATES ACT, 2003

Under section 18(2) of the Magistrates Act, 2003 (Act No. 3 of 2003), in consultation with the Magistrates Commission and with the concurrence of the Minister of Finance, I –

(a) increase the housing allowances and car allowances of magistrates as set out in the Schedule;

with effect from 1 April 2025.
