**COURT ORDER**

Having heard **MARIETTE BOONZAIER**, assisted by **JOHANNA HAMUNYELA** on behalf of the applicant and **WERNER KANIITA** on behalf of the respondent on 17 November 2025, and having read the notice of motion for INT-HC-OTH-2025/01369 and other documents filed of record, and having reserved judgment, thereafter on this day:

**IT IS ORDERED THAT:**

1. Save for costs on a punitive cost scale, the *rule nisi* issued on 3 September 2025 under INT-HC-OTH-2025/01369, read with annexures A and B thereto, is confirmed in the following terms:

- 1.1 The applicant's non-compliance with the forms, manner and service, and with the time limits prescribed by the rules of court is condoned and the matter is heard as one of urgency as envisaged in rule 73, thereby varying the time periods in the court order dated 22 August 2025, particularly the postponement of the matter to 10 October 2025, to 3 September 2025 at 09h00, and thereafter to 17 November 2025 at 08h30.
- 1.2 A preservation of property order as contemplated in section 51 of the Prevention of Organised Crime Act, 2004 (Act No. 29 of 2004) (POCA) is granted in respect of the red Volkswagen VW 360-Golf with vehicle identification number WVWZZZ1KZDW014516, engine number CCZ219733 and licence No. RZJ810H (the Golf).
- 1.3 Costs are granted against the respondent on the scale as between party and party.
- 1.4 In terms of section 51 of POCA, all persons with knowledge of this order, other than as required and permitted by this order, are prohibited from removing, and or taking possession of and/or control over, and/or dissipating, and/or encumbering and/or interfering with, and/or diminishing the value of, and/or attaching in execution, and/or dealing in any other manner with the Golf.
- 1.5 Detective Senior Inspector Johan Green of the Anti-Money Laundering and Combating of Financing and Terrorism: Asset Recovery Sub-Division, or in his absence, any authorised member of the Anti-

Money Laundering and Combating of Financing and Terrorism: Asset Recovery Sub-Division in Windhoek, is appointed to take care of the Golf in terms of section 93 of POCA and is immediately authorised to:

- 1.5.1 Seize and or assume control over the Golf;
- 1.5.2 Safeguard the Golf pending finalisation of forfeiture proceedings under POCA;
- 1.5.3 If necessary, to administer and preserve the Golf and to do all things necessary for that purpose.

- 1.6 The applicant must:

- 1.6.1 Effect service of the preservation of property order and the application on:

- 1.6.1.1 Mr Michael A. Citarelli; and

- 1.6.1.2 Mr Hans Natangwe  
Nghilifavali Shipulwa;

- 1.6.2 In terms of section 52(1)(b) of POCA, cause notice of this order, in the form set out in annexure A and annexure B hereto, to be published in the *Gazette* as soon as practicable after the preservation of property order is granted.

- 1.10.2 The nature and extent of his or her interest in the property concerned;
- 1.10.3 Whether he or she intends to oppose the making of the forfeiture order, or whether he or she intends to apply for an order excluding his or her interest in that property from the operation of the order;
- 1.10.4 Whether he or she admits or denies that the property concerned is the proceeds of unlawful activities and the basis for such defence; and
- 1.10.5 If he or she intends to apply for the exclusion of his or her interests from the operation of the forfeiture order, the basis for such an application.

1.11 Any person with an interest in the Golf may, on good cause shown:

- 1.11.1 In terms of section 57 of POCA, apply to the court for payment from the property of reasonable living expenses and reasonable legal expenses on conditions set out in section 57 of POCA;
- 1.11.2 In terms of section 58 of POCA, apply for the variation or rescission of the preservation order on the conditions set out in section 58 of POCA. The application under INT-HC-OTH-2025/01369 is finalised and removed from the roll.
