PROCEDURE FOR ADVERTISING IN THE GOVERNMENT GAZETTE OF THE REPUBLIC OF NAMIBIA

1. The *Government Gazette* (Estates) containing advertisements, is published on every Friday. If a Friday falls on a Public Holiday, this *Government Gazette* is published on the preceding Thursday.
2. Advertisements for publication in the *Government Gazette* (Estates) must be addressed to the Government Gazette office, Private Bag 13302, Windhoek, or be delivered at Justitia Building, Independence Avenue, Second Floor, Room 219, Windhoek, not later than **12h00** on the ninth working day before the date of publication of this *Government Gazette* in which the advertisement is to be inserted.
3. Advertisements are published in this *Government Gazette* for the benefit of the public and must be furnished in English by the advertiser or his agent.
4. Only legal advertisements shall be accepted for publication in the *Government Gazette* (Advertisements) and are subject to the approval of the Executive Director, Ministry of Justice, who may refuse the acceptance of further publication of any advertisement.
5. The Ministry of Justice reserves the right to edit and revise copy and to delete there from any superfluous detail.
6. Advertisements must as far as possible be typewritten. The manuscript of advertisements must be written on one side of the paper only and all proper nouns plainly inscribed. In the event of any name being incorrectly printed as a result of indistinct writing, the advertisement can only be reprinted on payment of the cost of another insertion.
7. No liability is accepted for any delay in the publication of advertisements/notices, or for the publication of such on any date other than that stipulated by the advertiser. IT IS ORDERED THAT:

1. The forms and service provided for in the rules of court are dispensed with, and the Applicants' non-compliance with the forms and service provided for in the rules of court, and any other non-compliances, are condoned, and the application is heard as an urgent application as contemplated in rule 73 of the rules of court.
2. The joint estate of the Respondents is hereby placed under a provisional order of sequestration and is placed under the control of the Master of the High Court until the appointment of a provisional trustee.
3. The trustee is appointed by the Master shall have the powers to bring and defend legal proceedings as envisaged in section 18(3) of the Insolvency Act, 1936 (Act No. 24 of 1936), as amended.
4. A *rule nisi* is hereby issued, returnable on 20 January 2026 at 15h30, or so soon thereafter as Counsel for the Applicants may be heard, calling upon the Respondents or any other interested party to show cause why:
 - 4.1 a final order of sequestration in respect of the Respondents' joint estate should not be granted; and
 - 4.2 the costs of this application, including the costs of one instruction and two instructed Counsel, should not be paid from the insolvent joint estate of the Respondents, and any party opposing the application should not be ordered, together with the Respondents, jointly and severally, the one paying the other to be absolved, to pay the cost of this application.
