## PROCLAMATION

*State President of the Republic of South Africa*

**No. R. 57, 1987**

AMENDMENT OF ADMINISTRATION OF ESTATES ACT, 1965, SO AS TO PROVIDE FOR THE PAYMENT OF MONEYS INTO THE GUARDIAN'S FUND OF SOUTH-WEST AFRICA

Under section 38 (1) of the South-West Africa Constitution Act, 1968 (Act 39 of 1968), I hereby make the law set out in the Schedule.

### SCHEDULE

#### *Amendment of section 86 of Act 66 of 1965*

1. Section 86 of the Administration of Estates Act, 1965 (Act 66 of 1965), is hereby amended by the addition of the following subsection:

“(3) Moneys in the guardian's fund received by the Master of the Supreme Court of South-West Africa on or before 31 March 1987 for the benefit of the said guardian's fund, together with the interest allowed thereon in terms of section 88, shall be paid into the guardian's fund of South-West Africa on 1 April 1987.”

#### *Short title and commencement*

2. This Proclamation shall be called the Administration of Estates Amendment Proclamation, 1987, and shall come into operation on 1 April 1987.
