AMENDMENT OF REGULATIONS MADE UNDER THE CURRENCY AND EXCHANGES ACT, 1933 (ACT 9 OF 1933)

The State President has, under section 9 of the Currency and Exchanges Act, 1933 (Act 9 of 1933), made the regulations contained in the Schedule.

SCHEDULE

AMENDMENT OF REGULATION 2 OF THE REGULATIONS PUBLISHED BY GOVERNMENT NOTICE R. 603 OF 27 MARCH 1986, AS AMENDED BY GOVERNMENT NOTICE R. 1078 OF 9 JUNE 1986

1. Regulation 2 of the Regulations published by Government Notice R. 603 of 27 March 1986 is hereby amended by the substitution for the words preceding paragraph (a) of the following words:

“No person shall with effect from 1 July 1987 until 30 June 1990 make payment to or in favour of any foreign creditor except payment into a special restricted account and except payment in respect of—”.

2. This Regulation shall come into operation on 1 July 1987.

“Niemand mag met ingang van 1 Julie 1987 tot 30 Junie 1990 enige betaling aan of ten gunste van enige buitelandse skuldeiser maak nie behalwe betaling in 'n spesiale beperkte rekening of betaling ten opsigte van—”.
