EXCHANGE CONTROL: AMENDMENT OF REGULATIONS MADE UNDER SECTION 9 OF THE CURRENCY AND EXCHANGES ACT, 1933 (ACT 9 OF 1933)

The State President has, under section 9 of the Currency and Exchanges Act, 1933 (Act 9 of 1933), made the regulations set out in the Schedule.

SCHEDULE

Amendment of regulation 22D of the regulations published by Government Notice R. 1111 of 1 December 1961, as inserted by regulation 7 of the regulations published by Government Notice R. 957 of 4 May 1987

1. Regulation 22D of the regulations published by Government Notice R. 1111 of 1961 is hereby amended by the deletion in paragraph (a) of the words "at any time before the date of publication of the notice referred to in regulation 22B (3)".

Commencement of these regulations

2. These regulations shall be deemed to have come into operation on 1 December 1961.
