PROCLAMATION

No. R. 307, 1967.]

MEALIE AND KAFFIRCORN CONTROL SCHEME.—AMENDMENT.

Whereas the Minister of Agricultural Economics and Marketing has, in terms of section 17 (3) (c), read with section 23 (4) of the Marketing Act, 1937 (No. 26 of 1937), accepted the proposed amendment as set out in the Schedule hereto, to the Mealie and Kaffircorn Control Scheme, published by Proclamation No. R. 113 of 1961, as amended, and has in terms of section 21 (1) (b) of the said Act, recommended the approval of the said proposed amendments;

Now, therefore, under the powers vested in me by section 22 (1) (a), read with section 23 (4) of the said Act, I do hereby declare that the said amendment shall come into operation on the date of publication hereof.

SCHEDULE.

The Mealie and Kaffircorn Control Scheme published by Proclamation No. R. 113 of 1961, as amended, is hereby further amended as follows:—

1. Section 19 is hereby amended by the substitution for subsections (3), (4) and (5) of the following subsections:—

“(3) The board shall in respect of every committee appointed by it, make rules with regard to the conduct of and procedure at meetings (including the quorum), the manner in which meetings shall be called and matters incidental thereto.

(4) A decision of the majority of all the members of any committee shall constitute the decision of the committee, unless the board, with the consent of the Minister, determines otherwise.

(5) The chairman of the board shall *ex officio* be a member of any committee appointed by the board.”.

2. Section 25 is hereby amended by—

(1) the substitution for paragraph (i) of the following paragraph:—

“(i) to buy mealies, mealie products, kaffircorn and kaffircorn products at such a price or on such a basis as the Minister may approve;”; and

BYLAE.

Die Mielie- en Kafferkingreëlingskema aangekondig by Proklamasie No. R. 113 van 1961, soos gewysig, word hierby verder soos volg gewysig:—

1. Artikel 19 word hierby gewysig deur subartikels (3), (4) en (5) deur die volgende subartikels te vervang:—

„(3) Die raad moet ten opsigte van elke komitee wat hy aanstel, reëls neerlê met betrekking tot die hou van en die prosedure op vergaderings (met inbegrip van die kworum), die wyse waarop vergaderings belê moet word en aangeleenthede in verband daarmee.

(4) 'n Besluit van die meerderheid van al die lede van 'n komitee maak 'n besluit van die komitee uit, tensy die raad met goedkeuring van die Minister anders bepaal.

(5) Die voorsitter van die raad is *ex officio* lid van elke komitee wat deur die raad benoem word.”.

2. Artikel 25 word hierby gewysig deur—

(1) paragraaf (i) deur die volgende paragraaf te vervang:—

„(i) teen die prys of op die grondslag wat die Minister goedkeur mielies, mielieprodukte, kafferking en kafferkingprodukte te koop;”; en

(2) the substitution for paragraph (k) of the following paragraph:—

“(k) to sell, whether in its original form or processed wholly or in part, mealies, mealie products, kaffircorn and kaffircorn products which it has bought, at such a price or on such a basis as the Minister may approve, or to withhold any part of it from the market;”.

3. Section 26 is hereby amended by the substitution for paragraph (c) of the following paragraph:—

“(c) with the approval of the Minister, from time to time to prohibit any producer of mealies or any mealie product from selling mealies or any mealie product which he has produced except such class, grade, quantity or percentage thereof as the Board has determined or except for such purposes as the Board has defined;”.

4. Section 28 is hereby amended by the deletion of subsection (2).

UNIVERSITIES ACT, 1955.

UNIVERSITY OF PRETORIA.—AMENDMENT OF STATUTE.

The Minister of Education, Arts and Science has, under and by virtue of the powers vested in him by section 17 (2) of the Universities Act, 1955 (Act No. 61 of 1955), approved the following amendments to the Statute of the University of Pretoria, published under Government Notice No. R. 93 of 24 January 1964, as amended by Government Notices No. R. 198 of 14 February 1964, No. R. 1493 of 1 October 1965, No. R. 613 of 22 April 1966 and No. 726 of 19 May 1967:—

1. The following paragraph is substituted for paragraph 59:—
