LEVY ON WOOL.

Kragtens artikel *elf* van die Wolkommissie- en Wolwysigingswet, 1960 (Wet No. 35 van 1960), maak ek, DIRK CORNELIS HERMANUS UYS, Minister van Landbou-ekonomie en -bemarking, hierby bekend dat die Suid-Afrikaanse Wolkommissie, genoem in artikel *twee* van die genoemde Wet, met my goedkeuring die volgende heffings opgelê het, ter vervanging van die heffings bekendgemaak by Goewermentskennisgewing No. R. 934 van 1 Julie 1960:—

In terms of section *eleven* of the Wool Commission and Wool Amendment Act, 1960 (Act No. 35 of 1960), I, DIRK CORNELIS HERMANUS UYS, Minister of Agricultural Economics and Marketing, hereby make known that the South African Wool Commission referred to in section *two* of the said Act, has, with my approval, imposed the following levies in substitution for the levies made known by Government Notice No. R. 934 of the 1st July, 1960:—

- (a) 'n Heffing van twee-vyfdes sent ($\frac{2}{5}$ c) per pond op alle wol, uitsluitende Karakoelwol, wat in die Republiek geproduseer, verkoop of verwerk of uit die Republiek uitgevoer word; en
- (b) 'n heffing van een-vyfde sent ($\frac{1}{5}$ c) per pond op alle Karakoelwol wat in die Republiek geproduseer, verkoop of verwerk of uit die Republiek uitgevoer word.

- (a) A levy of two-fifths cent ($\frac{2}{5}$ c) per pound on all wool, excluding Karakul wool, produced, sold or processed in or exported from the Republic; and
- (b) a levy of one-fifth cent ($\frac{1}{5}$ c) per pound on all Karakul wool produced, sold or processed in or exported from the Republic.

The levies shall come into operation on the 1st July, 1961.
