**CHILDREN'S ACT, 1960 (ACT 33 OF 1960).—
AMENDMENT OF REGULATIONS**

Under and by virtue of the powers vested in me by section 92 of the Children's Act, 1960 (Act 33 of 1960), read with Proclamation 42 of 1968, I, Marais Viljoen, Minister of Coloured Affairs, hereby amend the regulations published under Government Notice R. 236 dated 21 February 1964 with retrospective effect from 1 April 1963 as follows:—

By the substitution of the following for paragraph (a) of regulation 47:—

“(a) An association of persons for the care of children over the age of one month and under seven years of—

(i) *bona fide* working mothers who must of necessity work away from their homes;

(ii) *bona fide* work-seeking mothers who have lost their employment;

**KINDERWET, 1960 (WET 33 VAN 1960).—
WYSIGING VAN REGULASIES**

Kragtens die bevoegdheid my verleen by artikel 92 van die Kinderwet, 1960 (Wet 33 van 1960), gelees met Proklamasie 42 van 1968, wysig ek, Marais Viljoen, Minister van Kleurlingsake, hierby, met terugwerkende krag vanaf 1 April 1963, die regulasies afgekondig by Goewermentskennisgewing R. 236 van 21 Februarie 1964, soos volg:—

Deur paragraaf (a) van regulasie 47 deur die volgende te vervang:—

“(a) 'n Vereniging van persone vir die versorging van kinders oor die ouderdom van een maand en onder sewe jaar van—

(i) *bona fide* werkende moeders wat noodwendig buitenshuis moet werk;

(ii) *bona fide* werksoekende moeders wat hul werk verloor het;

(iii) *bona fide* working widowers who, on account of circumstances, are prevented from taking care of their children at home during the day;

(iv) *bona fide* work-seeking widowers who have lost their employment and who, on account of their absence from home while seeking employment, are prevented from taking care of their children at home during the day."

DEPARTMENT OF JUSTICE

PROHIBITION OF THE KEEPING OR USE OF CERTAIN PIN-TABLES, MACHINES, CONTRIVANCES OR INSTRUMENTS

Whereas pin-tables, machines, contrivances or instruments of the class or kind described in the Schedule are in my opinion intended for the playing of games of chance:—

Now therefore I, Petrus Cornelius Pelser, Minister of Justice, do hereby, by virtue of the powers vested in me under section 7 (1) of the Gambling Act, 1965 (Act 51 of 1965), prohibit with effect from 1 July 1969, the keeping or use of any pin-table, machine, contrivance or instrument of the class or kind so described at any place where a business is conducted for which a licence referred to in Part I of the Second Schedule to the Licences Act, 1962 (Act 44 of 1962), is required, and at any other place to which the public has access.

SCHEDULE

Any pin-table, machine, contrivance or instrument (hereinafter referred to as "the apparatus") intended for the playing of any game in the playing of which one or more components of the apparatus or one or more objects placed in or on or fitted on the apparatus, start moving or are set in motion, and which has no equipment being an integral part thereof by means of which any person can at any time during the course of the game immediately stop the said components or objects at will without ending or interrupting the game.

WET OP DIE BEHEER VAN BOKS EN STOEL, 1954 (WET 39 VAN 1954)
WYSIGING VAN BOKSBEHEERREGULASIES

Kragtens artikel 9 van die Wet op die Beheer van Boks en Stoei, 1954 (Wet 39 van 1954), en met die goedkeuring van die Minister van Polisie, wysig die Suid-Afrikaanse

Control Board hereby amends the regulations promulgated under Government Notice R. 423 of 22 March 1963, as follows:—

Regulation 14.—Delete and substitute the following therefor:—

WEIGHTS

14. Contestants for championship titles shall be weighed in the nude. The standard weight in respect of the various divisions shall be:—

- Flyweight up to and including 112 lb.
- Bantamweight over 112 lb up to and including 118 lb.
- Featherweight over 118 lb up to and including 126 lb.
- Junior Lightweight over 126 lb up to and including 130 lb.
- Lightweight over 130 lb up to and including 135 lb.
- Junior Welterweight over 135 lb up to and including 140 lb.
- Welterweight over 140 lb up to and including 147 lb.
- Junior Middleweight over 147 lb up to and including 154 lb.
- Middleweight over 154 lb up to and including 160 lb.
- Light-heavyweight over 160 lb up to and including 175 lb.
- Heavyweight more than 175 lb.

4. Send remittances by Postal Order or Money Order.
5. Pack parcels properly, using strong containers and heavy paper. Tie securely.
6. Prepay postage fully.
7. Place postage stamps in the upper right hand corner of the envelope or wrapper.
8. Insure your parcels and register valuable letters. Documents which can only be replaced at considerable cost should preferably be insured.
9. Post early and often during the day. Mail held until the last moment may cause delay.
10. Give your correspondents your correct post office address including your box number where applicable.

2. Plaas u eie adres agterop die koevert of omslag.
3. Moenie muntstukke of ander harde artikels in briewe insluit nie.
4. Gebruik posorders of poswissels wanneer geld deur die pos gestuur word.
5. Verpak pakkette behoorlik. Gebruik sterk houers en dik papier en bind dit stewig vas.
6. Maak seker dat die posgeld ten volle vooruitbetaal is.
7. Plak die posseëls in die boonste regterhoek van die koevert of omslag.
8. Verseker u pakkette en registreer waardevolle briewe. Dokumente wat slegs teen hoë koste vervang kan word, moet verkieslik verseker word.
9. Pos vroegtydig en dikwels gedurende die dag. Posstukke wat tot op die laaste oomblik teruggehou word kan vertraging veroorsaak.
10. Verstrek u volledige posadres aan u korrespondente asook u posbusnommer waar van toepassing.
