The State President has been pleased, under the provisions of sub-section (4) of section two and of section three of Act No. 44 of 1958, to approve of the following amendment to the Telephone Regulations:—

*Regulation No. 44.*

Add the following:—

“Transistor ringing generator on switchboard ... .. R5.00.  
 (If a switchboard is already installed at a subscriber's premises, a fixed amount of R5.00 shall be raised for the fitting of a transistor ringing generator, in addition to the prescribed rental of R5.00 per annum.)”
