**DEPARTEMENT VAN VERVOER**

No. R. 142 30 Januarie 1976

**STAATSLUGHAWEREGULASIES, 1963**

Die Minister van Vervoer het kragtens artikel 22 van die Lugvaartwet, 1962 (Wet 74 van 1962), soos gewysig, die regulasies in die Bylae hiervan vervat, uitgevaardig.

**BYLAE 12**

Die Staatslughaweregulasies, 1963, soos afgekondig by Goewermentskennisgewing R. 1974 van 20 Desember 1963, en soos gewysig\*, word hierby soos volg verder gewysig met ingang van 1 April 1976:

1. Regulاسie 13A word gewysig—

(1) deur in subregulasie (1) die uitdrukking “en (3)” deur die uitdrukking “, (3) en (4)” te vervang; en

(2) deur die volgende subregulasie by te voeg:

“(4) Geen landingsgeld is betaalbaar nie ten opsigte van 'n lugvaartuig waarmee 'n proefvlug uitgevoer word, wanneer sodanige vlug deur die Kommissaris van Burgerlugvaart vereis word, ooreenkomstig die regulasies uitgevaardig ingevolge die Wet met die oog op die uitreiking van of verlenging van regs krag aan 'n lugwaardigheidsertifikaat of nadat 'n groot verandering aan 'n lugvaartuig aangebring is.”.

**STATE AIRPORT REGULATIONS, 1963**

The Minister of Transport has, in terms of section 22 of the Aviation Act, 1962 (Act 74 of 1962), as amended, made the regulations contained in the Schedule hereto.

**SCHEDULE 12**

The State Airport Regulations, 1963, as promulgated under Government Notice R. 1974 of 20 December 1963, and as amended\*, are hereby further amended as follows with effect from 1 April 1976:

1. Regulation 13A is amended—

(1) by the substitution in subregulation (1) for the expression “and (3)” of the expression “, (3) and (4)”; and

(2) by the addition of the following subregulation:

“(4) No landing charge shall be payable in respect of an aircraft engaged in a test flight, when such flight is required by the Commissioner for Civil Aviation in terms of the regulations made under the Act for the purpose of issuing or rendering effective a certificate of airworthiness or after any major modification to an aircraft.”.

**DIE BLOMPLANTE VAN AFRIKA**

Hierdie publikasie word uitgegee as 'n geïllustreerde reeks, baie na die aard van Curtis se "Botanical Magazine". Die doel van die werk is om die skoonheid en variasie van vorm van die flora van Afrika aan die leser bekend te stel, om belangstelling in die studie en kweek van die inheemse plante op te wek, en om plantkunde in die algemeen te bevorder.

Die meeste van die illustrasies word deur kunstenaars van die Navorsingsinstituut vir Plantkunde gemaak, dog die redakteur verwelkom geskikte bydraes van 'n wetenskaplike en kunsstandaard afkomstig van verwante inrigtings.

Onder huidige omstandighede word twee dele van die werk gelyktydig gepubliseer, maar met onreëlmatige tussenpose; elke deel bevat tien kleurplate. Intekengeld bedra R1,50 per deel: Vier dele per band. Vanaf band 27 is die prys per band in linne gebind R10; in morocco-leer gebind R14.
